

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

**Admission of F. P. Walton to Bar.** **1.** The Bar of the Province of Quebec is hereby authorized to admit the said Frederick Parker Walton among its members after such examination as it shall see fit to require.

**Coming into force.** **2.** This act shall come into force on the day of its sanction.

## CHAP. 156

An Act to authorize the Bar of the Province of Quebec to admit Joseph Arthur Alphonse Pigeon amongst its members, after examination.

*[Assented to 28th February, 1907]*

Preamble.

**W**HEREAS Joseph Arthur Alphonse Pigeon, notary, of the parish of St. George de Henryville, in the district of Iberville, has by his petition, represented :

That he is thirty-two years of age ;

That he followed a complete course of classical studies at the college of L'Assomption ;

That Laval University conferred upon him the degree of Bachelor of Arts ;

That he followed a course of law lectures at Laval University at Montreal for three years, and obtained from said university the degree of Licentiate in Law ;

That he was admitted to the practice of the notarial profession on the 9th September, 1900, and has practised such profession since the said date ;

That he possesses the necessary legal knowledge and experience to allow of his being admitted as an advocate, although he has not complied with the formalities respecting the admission to study and clerkship ;

That he wishes to practise the profession of advocate, and that the General Council of the Bar of this Province has approved the petitioner's request, by resolution of the 27th December, 1906 ;

Whereas the petitioner has prayed that an act be passed to that effect, and it is expedient to grant such prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

**1.** The Bar of the Province of Quebec is authorized to admit Joseph Arthur Alphonse Pigeon to the practice of the legal profession, upon his undergoing the usual examination for admission to practice.

**2.** This act shall come into force on the day of its sanction.

## CHAP. 157

An Act to authorize the Bar of the Province of Quebec to admit Joseph Henry Dillon as one of its members, after examination

[Assented to 28th February, 1907]

**WHEREAS** Joseph Henry Dillon, student-at-law, of the city of Montreal, has, by his petition, represented :

That on the 8th July, 1904, he was admitted to the study of law and the certificate to that effect was registered on the same day.

That at the date of his admission to the study of law he was secretary of the road committee of the city of Montreal and at the same time following the office of the city attorney, Mr. L. J. Ethier K. C., though not regularly indentured to him, and continued so to follow said office until the 3rd May, 1906, when he was indentured to Mr. W. J. White, D. C. L., K. C.,

That he is following the law course of McGill University and will have completed the same in April, 1907.

That owing to the fact that he was not regularly indentured to Mr. L. J. Ethier, K. C., he will be unable to present himself for examination for admission to the practice of law until 1909 ;

That the General Council of the Bar of the Province of Quebec has approved the passing of an act to authorize the Bar of the Province of Quebec to admit him as one of its members, after he shall have passed the examination for admission to the practice of law, on condition that he obtain the degree required by law, and after the expiry of three years from the date of the registration of his certificate of admission to the study of law ;

Whereas the petitioner has prayed that an act be passed to that effect, and it is expedient to grant his prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :
