

Bar of Province of Quebec may admit J. H. Dillon after examination, &c.

1. The Bar of the Province of Quebec is authorized to admit Joseph Henry Dillon as one of its members, after he shall have passed the examination for admission to the practice of law, on condition that he obtain the degree required by law, and after the expiry of three years from the date of registration of his certificate of admission to the study of law.

Coming into force.

2. This act shall come into force on the day of its sanction.

CHAP. 158

An Act to authorize the Bar of the Province of Quebec to admit Francis Henry Wilfrid Bovey among its members after examination.

[Assented to 28th February, 1907]

Preamble.

WHEREAS Francis Henry Wilfrid Bovey of the city of Montreal, barrister-at-law, hath by his petition represented :

That he is a Bachelor of Arts of McGill University, and that after graduating from McGill University he graduated in law from the university of Cambridge, in England, and was called to the English Bar, and that on the eighth day of July, 1904, he was admitted to the study of law in the Province of Quebec, and in the month of February of the same year was indentured to Alexander Falconer, Esq., K. C., advocate, of the city and district of Montreal ;

That never having served the term of clerkship required by law, he cannot until he has served such term obtain the diploma conferring the title of advocate ;

That he has prayed that the Bar of the Province of Quebec be authorized to admit him to the practice of an advocate ;

That the General Council of the Bar of the Province of Quebec has unanimously approved of the petitioner's application, and it is expedient to grant the prayer of the said petitioner ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

Bar of Province authorized to admit

1. The Bar of the Province of Quebec is hereby authorized to admit the said Francis Henry Wilfrid Bovey to the final

examination required for admission to the practice of law, F. H. W. and, upon his passing the same, to admit him as a member of Bovey, &c. the Bar of this Province.

CHAP. 159

An Act to authorize the Board of Notaries of the Province of Quebec to admit Raymond Belleau to practise the notarial profession.

[Assented to 28th February, 1907]

WHEREAS Raymond Belleau, advocate, of the town of Preamble.
Levis, has, by petition, represented :

That he obtained the degree of Bachelor of Letters and Licentiate in Law from Laval University, and was admitted to the Bar of this Province in July, 1905 ;

That he followed a complete course of classical study ;

That he was admitted to study the notarial profession in July, 1906 ; and since the fifth of January, 1906, he has been indentured to a practising notary ;

That, if he were compelled to remain under such indenture for three full years, he would suffer unnecessary loss of time in consequence of the knowledge he has acquired and of his studies, both at Laval University and as a student in an advocate's office ;

That the Board of Notaries of the Province of Quebec, at its sitting in July, 1906, granted its consent to the passing of an act to admit him to the practice of the notarial profession ;

Whereas the said Raymond Belleau has prayed that an act be passed to authorize the Board of Notaries to admit him to the practice of the notarial profession, and it is expedient to grant such prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :
