## C H A P. 47

An Act to incorporate the town of Marieville

[Assented to 20th May, 1905]

Preamble.

**W**HEREAS the corporation of the village of Marieville, incorporated under the provisions of the Municipal Code, has, by its petition, represented that, in view of the increase of the population and the industrial development of the municipality, it is expedient that it be incorporated as a town for all municipal purposes;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Town incor-  
porated.  
Name.

**1.** The corporation of the village of Marieville is incorporated as a town under the name of the "town of Marieville."

Law to  
govern.

The town shall be subject to the operation of the Cities and Towns' Act, 1903.

Boundaries  
of town.

**2.** The town of Marieville shall be bounded on the west and south by the present limits of the village of Marieville; on the south-east by a line starting from the south-east angle of lot number one hundred and eight (108) of the official plan and book of reference of the said village, deviating towards the south in the municipality of the parish of Ste. Marie de Monnoir, reaching to the south-west side of the road of the church range, which is a continuation of Marieville street, at a distance of three hundred and twenty feet to the south of the south-east corner of Marieville and Girouard streets, completed by following the west side of Marieville street,

crossing the latter street or road of the church range, and extending to lot number one hundred and fifty (150) of the official plan and book of reference of the said parish of Ste. Marie de Monnoir, in a slightly diagonal direction, in so far as may be necessary to reach the eastern line or boundary of the town, at a distance of one arpent from the north line of the said lot number one hundred and fifty (150); on the east by a line starting on the north from a point on the division line between lots one hundred and fifty and one hundred and fifty-one (150 and 151) of the same official plan and book of reference of Ste Marie de Monnoir, to a distance of four arpents to the east of the said Marieville street, counted by following the said division line, and from another point, to the north on the south side of the macadamized road or Poulin road in the said municipality of the parish of Ste. Marie de Monnoir, to a distance of one thousand feet east of Seraphin street, which line is intersected as well as the north half of lot number one hundred and fifty (150) and the whole of lots numbers one hundred and fifty one, one hundred and fifty-two, one hundred and fifty-four, one hundred and fifty-six, and one hundred and fifty-nine A (151, 152, 154, 156 and 159A) of the said official plan and book of reference of Ste. Marie de Monnoir; on reaching the northern line of the latter lot number one hundred and fifty-nine A (159A) the town line forms an angle, going in a direction from the east to the west, following said line for a distance of one hundred feet from the western limits of the Catholic cemetery of the parish of Ste. Marie de Monnoir, where the line forms a new angle, and runs from the south to the north on lot number one hundred and sixty-one (161) of the official plan and book of reference of the parish of Ste. Marie de Monnoir, to the exact one half of the width of said lot, following a line parallel to that which would be the prolongation of the western line of the said cemetery; on reaching the half of the width of the said lot number one hundred and sixty-one (161) or the existing line dividing it along its length, the boundary line of the town shall deviate from east to west, following such division line or middle of lot number one hundred and sixty-one (161) to St. Louis stream; from the latter point the line forms an obtuse angle, going in a straight line from north to west on the north-west angle of lot number one hundred and forty-nine (149) of the official plan and book of reference of the said village, crossing lots numbers two hundred and forty-eight, two hundred and fifty, and two hundred and fifty-two (248, 250 and 252) of the official plan and book of reference of the said parish of Ste. Marie de Monnoir. The quantities in feet above specified are English measure.

Existing regulations, &c.

**3.** All regulations, *procès-verbaux*, rolls, resolutions and ordinances of the municipal council of the village of Marieville, not inconsistent with the provisions of this act and now in force, shall remain in force until repealed, set aside or replaced by the ordinances of the town council.

Corporation to succeed village.

The corporation of Marieville shall succeed to all the rights and obligations of the corporation of the village of Marieville.

Certain proprietors not to pay certain debts.

**4.** The owners of property in the municipality of the parish of Ste. Marie de Monnoir, which is hereby included in the limits of the town, shall not contribute to the payment of the funded debts by the issue of debentures created by the village of Marieville before its incorporation as a town ; but they shall contribute to the debts of all kinds incurred for the acquisition and reconstruction of the water works.

Taxes to be levied on whole town and certain proprietors to be reimbursed for certain debts.

**5.** In order to simplify the operations for the levying and allotment of the yearly taxes on real estate liable for the payment of such debts, from which the lands dismembered from the municipality of the parish of Ste. Marie de Monnoir and annexed to the town are exempt, it shall be lawful for the town council to assess such taxes upon all taxable immoveables of the town, including those so dismembered, on condition of the reimbursement to the owners of the latter of their contributions to such debts appearing on the collection roll ; the town council shall have power to reimburse at any time to such property owners their total contribution to the said debts, basing such contributions on the valuation roll then in force.

Present division into wards.

**6.** The present division of the village of Marieville into three wards shall be retained for the town of Marieville, and that portion of the parish of Ste. Marie de Monnoir annexed to the town, shall be annexed to ward number one.

Power to change limits by by-law.

The town council may make, amend or repeal by-laws to change the limits of said wards and to increase the number thereof if it be deemed expedient.

Returning officer for first election.

**7.** Henri Sainte Marie, notary, of the said village of Marieville, shall be the returning officer for the first election ; but in the event of his death or of his becoming incapable or refusing to act, it shall be lawful for the Lieutenant-Governor, upon a petition of any elector of the town, to appoint a returning officer for such election.

First election when to be held.

**8.** The nomination of the candidates at the first general election of the mayor and aldermen of the town shall take

place on the first of August next, and the voting on the twelfth of the same month.

**9.** The first general session of the council shall take place in the court room of the Circuit Court of the county of Rouville, in the court house of the said village.

Where first session of council to be held.

**10.** There shall be six aldermen for the town, two for each ward, and the deposit required from candidates for the election to the office of alderman shall be twenty five-dollars, instead of fifty dollars.

Number of aldermen. Deposit by candidates for office.

**11.** Article 485 of the Cities and Towns' Act, 1903, is replaced, for the town, by the following :

The tax imposed in virtue of article 479 is payable for the carrying on of every kind of trade, business or occupation, even when carried on by the same person, firm or company.

Tax for all trades, &c., carried on by same person.

**12.** Article 525 of the said act is replaced, for the town, by the following :

Id., 525, replaced for town.

Loans, whether by issue of bonds or otherwise, are only made under a by-law of the council to that effect, approved by a majority in number and in real value of the proprietors and municipal electors who have voted. Nevertheless, without such approval being required, it shall be lawful for the council to borrow, by resolution, various sums of money on promissory notes of the corporation, at a rate of interest not exceeding six per cent. per annum ; but the unpaid capital of all notes so issued shall not exceed two thousand dollars.

Loans.

**13.** Article 302 of the said act is replaced, for the town, by the following :

The council shall meet at least once a month, in general or ordinary session to despatch the business of the town, and shall hold its sessions on the days and at the hours which are determined by by-law.

Meetings of council.

**14.** This act shall come into force on the day of its sanction.
