An Act respecting *La Compagnie du Pont Saint-Pie*

[Assented to 20th May, 1905]

Preamble.

WHEREAS *La Compagnie du Pont Saint-Pie*, a body politic, duly incorporated by letters patent issued under the great seal of the Province of Quebec, representing the rights conferred upon Hilaire Th  berge by the act 26 Victoria, chapter 32, has, by its petition, represented that it is necessary to rebuild the bridge to which the said act relates, and that the present site of the said bridge is difficult of approach and unsuitable for rebuilding ;

Whereas the said company prays that it be authorized to rebuild such bridge on another site than the present one, and that the said act be amended to that effect ; and whereas it is expedient to grant its prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

Rebuilding of
bridge on dif-
ferent site au-
thorized.

1. The said bridge, toll-house, gates and other things relating to the operation of the said bridge, may be rebuilt at a distance of about one hundred and twenty yards above the railway bridge at present used by the Canadian Pacific Railway Company, in the parish of St. Pie, in the county of Bagot, over the south branch of the river Yamaska, on lot number six hundred and thirty-seven (637) of the official cadastre of the parish of St. Pie, in the village of St. Pie, on the north-east side of the river Yamaska, and, on the south-west side of the said river, on lot number six hundred and sixty-two (662) of the said cadastre of the parish of St. Pie ; provided always that the said bridge shall be rebuilt according to the following dimensions : two hundred and ten feet in length, eighteen feet in width and fifty feet of span between the piers ; the height of the piers to be seventeen feet.

Power to ex-
propriate
lands for
bridge, &c.

2. *La Compagnie du Pont Saint-Pie* and its assigns shall have the right and power to proceed to the expropriation of all lands needful or useful to the construction, keeping and maintenance of the said bridge, toll-house, gates and all other things relating to the operation of said bridge.

Rights of
company, &c.

3. For the rebuilding at such place of the said bridge, toll-house, gates and other things relating to the operating

of the said bridge, as well as for its operating, keeping and maintenance, *La Compagnie du Pont Saint-Pie* and its assigns and successors shall have and enjoy all the rights, powers and privileges conferred upon the said Hilaire Théberge, his heirs and assigns, their *auteurs*, by the said act 26 Victoria, chapter 32.

4. The corporations of the parish and of the village of Bridge, &c., St. Pie may, at any time, jointly or separately, expropriate the rights, privileges and property of *La compagnie du Pont St. Pie*, according to the method followed for railway expropriations. may be expropriated by certain municipality.

5. This act shall come into force on the day of its sanction. Coming into force.

C H A P. 87

An Act to incorporate the Hampton Court Company

[Assented to 20th May, 1905]

WHEREAS Joseph S. Baker, of the village of Dunham, in the Province of Quebec, farmer; Malcolm Clapp Baker, veterinary-surgeon; George H. Harrower, merchant; John Murphy, merchant; Hugh Henry, merchant; Annie W. Gill, spinster, and George R. Lighthall, notary; all of the city of Montreal, and Frederick William Hibbard, of the town of Westmount, advocate, have, by their petition, represented : Preamble.

That the petitioners, herein named, are desirous of being constituted a corporation, with the powers hereinafter stated, for the purpose of acquiring immoveable property, and constructing thereon apartment buildings, and to lease, sell and otherwise dispose of the same ;

Whereas, as to all the foregoing, they have, by their petition herein, duly prayed, and whereas it is expedient to grant their prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and the Legislative Assembly of Quebec, enacts as follows :

1. The petitioners, hereinabove named, and such persons as may hereafter become shareholders in such company, are hereby constituted a body politic and corporate under the name of the " Hampton Court Company." Persons incorporated. Name.
