That he followed a course of classical studies at the Quebec Seminary as far as rhetoric, but was obliged to discontinue, and has since been unable to pass his examinations for admission to the study of law, for certain reasons set forth in a petition addressed by him to the general council of the Bar of the Province of Quebec, praying it to approve of the passing of a private bill ;

That the said general council of the Bar of the Province of Quebec, at its sitting on the 14th June, 1904, unanimously approved the said petition ;

Whereas the petitioner has prayed that an act be passed to that effect, and it is expedient to grant such prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

Admission of

1. The Bar of the Province of Quebec is authorized to admit Theodore Dubé to the profession of advocate, when he shall have regularly obtained his university degrees and the required certificate from his patron, and after he shall have passed the examinations required by law for admission to the practice of the said profession, and the said Theodore Dubé is and shall be, for all purposes, considered hereby as under indenture and as having been admitted to the study of law in July, 1902, after all required examinations.

2. This act shall come into force on the day of its sanction.

C H A P . 1 1 4

An Act to authorize the Bar of the Province of Quebec to admit Antonio Perrault among its members, after examination.

[Assented to 20th May, 1905]

Preamble.

WHEREAS Antonio Perrault has, by his petition, represented :

That he completed his classical studies at the Quebec Seminary on the twentieth June, 1901, after obtaining the degree of Bachelor of Arts ;

That, at the beginning of July in the same year (1901) he entered the office of J. E. Perrault, Esquire, advocate, at Arthabaska, as a student at law and continued there as such up to the fifth of September, 1902, and that during that time

he received instruction in law and assiduously attended the office and the courts ; but was not indentured by deed to the said J. E. Perrault ;

That, from February, 1903, to July, 1903, he continued to attend the office of the said J. E. Perrault ;

That, on the tenth July, 1903, on presenting his diploma of Bachelor of Arts, he was admitted to the study of law, in the city of Quebec ;

That, on the eleventh July, 1903, he was indentured to the said J. E. Perrault, advocate, and continued to attend the latter's office until the fifteenth September, 1904, having attended the office and the courts during all that time ;

That, on the fifteenth September, 1904, he entered Laval University, at Montreal, to follow the law course there, which he will attend until June, 1906 ;

That he transferred his indentures on the eighth November, 1904, to Messrs. Blair and Laverty, advocates, of the city of Montreal ;

That he wishes to present himself at the examination for admission to the practice of law in the month of July, 1906, when he will have attended an advocate's office for four years and a half and the law course of Laval University for two years ;

That, as he was not indentured in 1901 to the said J. E. Perrault, he would only be able to present himself for the examination for admission to the practice of law in July, 1907 ;

That, on the ninth of March, 1905, he applied to the general council of the Bar of this province for authorization to submit this act to the Legislature ;

That the said general council of the Bar of this province authorized him to present a bill to the following effect ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly, enacts as follows :

1. Antonio Perrault is authorized to present himself at the law examinations to be held in July, 1906, and the Bar of the Province of Quebec is authorized to admit him among its members, after he shall have passed the final examination in July, 1906 ; and the said Antonio Perrault is and shall be, for all purposes, considered hereby as under indenture and as having been admitted to the study of law in July 1901, after all required examinations.
