An Act to amend the Quebec Pharmacy Act

[Assented to 25th April, 1903]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

Coming

1. The following article is inserted in the Revised Statutes, after article 4052 :

“**4052a.** Nothing in articles 84, 99, 100 or 105 of the Quebec License Law shall be so construed as to prevent chemists and druggists, duly registered as such in virtue of the Quebec Pharmacy Act, from selling all medicinal preparations containing alcohol, so long as these preparations are sold for medicinal use only ; or from selling rectified spirit (ninety per cent. alcohol) of the British Pharmacopoeia, for medicinal, mechanical or scientific purposes in quantities of not more than one imperial pint, provided every sale of such rectified spirit be registered in the register of sales of liquor referred to in the second paragraph of article 105 of the Quebec License Law.”

2. This act shall come into force on the day of its sanction.

CH A P. 37

An Act respecting the liberal professions

[Assented to 25th April, 1903]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

Prohibition :

From pub-
lishing cer-
tain notices of
application to
Legislature
or printing
certain Bills.

1. No person shall :

(a) if he is the King's printer, publish in the *Quebec Official Gazette*, a notice that a Bill will be presented to either House of the Legislature of Quebec authorizing the admission to the study or practice of any one of the liberal professions ; or

(b) if he is the clerk or clerk of private bills of one of the Houses of the Legislature of Quebec, receive any such Bill or have it printed ;

unless the notice or the Bill be accompanied by a certificate establishing that the Bill has been approved by the board or council of management of the profession which it concerns. Proviso.
