

## CHAP. 118

An Act to incorporate *L'Hôpital Guay de Saint Joseph de Lévis*

[Assented to 25th April, 1903]

Preamble.

WHEREAS, by his petition, *Monseigneur Charles Guay*, Apostolic Prothonotary *ad instar participantium*, has represented ;

That he had donated all his moveable and immoveable property on the twenty-first day of December, one thousand, nine hundred and one, to the *Institut des Sœurs de Notre-Dame du Bon Conseil de Chicoutimi*, a body politic, whose corporate seat is in the town of Chicoutimi, county of Chicoutimi, for the foundation of an hospital in his native parish of St. Joseph de Lévis, county of Levis ;

That one of the principal conditions of such gift is that the aforesaid moveables and immoveables given to the *Institut des Sœurs de Notre-Dame du Bon Conseil de Chicoutimi*, shall all, without exception, belong *de jure* to the *Hôpital Guay de Saint Joseph de Lévis*, as soon as the latter shall be incorporated under the name of *L'Hôpital Guay de Saint Joseph de Lévis* ;

That the Sisters of the *Institut de Notre-Dame du Bon Conseil de Chicoutimi* have, since such gift, opened a house of refuge for the aged poor, infirm and cripples of both sexes in the parish of St. Joseph de Lévis, in one of the properties donated by *Monseigneur Charles Guay* ;

That it is in the interest of the poor that such house of refuge be incorporated ;

Whereas, in his petition, *Monseigneur Charles Guay* has prayed that an act be passed to that effect, and it is expedient to grant such prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

Certain persons incorporated.

Control of certain institutions and its powers

1. The superioress, sister St. Gabriel, the assistant superioress, sister Sainte Marie de l'Eucharistie, the depositary, sister Saint Pierre, and the assistant-depositary, sister Saint Joseph, the *econome* sister Sainte Thérèse, and such others as shall succeed them in office, shall constitute the corporation of *L'Hôpital Guay de Saint Joseph de Lévis*, under the authority of the superioress-general of the *Institut des Sœurs de Notre-Dame du Bon Conseil de Chicoutimi* and of its council, and each of them may be removed and shall be

replaced according to the rules and statutes of the said *Institut des Sœurs de Notre-Dame du Bon Conseil de Chicoutimi*. over members of corporation.

**2.** All the moveable and immoveable property already given to the said *Institut des Sœurs de Notre-Dame du Bon Conseil* by the said *Monseigneur Charles Guay*, or other persons, and also all the moveable and immoveable property which the said *Monseigneur Charles Guay* may leave at his death, and which he shall not have otherwise disposed of previous to his decease, shall be transferred to the said corporation of *L'Hôpital Guay de St. Joseph de Lévis*, and be by it enjoyed, done with and disposed of, managed, administered and employed according to the intentions of the donors and testators. Certain property vested in corporation.

**3.** All the property, moveable and immoveable, or all gifts or legacies whatsoever which the corporation of *L'Hôpital Guay de St. Joseph de Lévis* has acquired or may acquire or shall be made or assigned to it, shall always be devoted to the purposes of the said hospital, and no one whomsoever shall be, at any time, permitted to take away any portion thereof to be transferred elsewhere. Application of property.

**4.** The corporation may have a seal which it may change at will, and it shall be vested with all the rights, powers and privileges inherent in other corporations recognized by law. Seal of corporation and corporate rights.

**5.** It may appear before the courts, sue and be sued before any court of justice of the province under its corporate name, in the same manner as any other person or corporation. Power to sue, &c.

**6.** It may possess, acquire and receive, by purchase, gift, will, legacy, assignment, exchange, or by any other legal title whatsoever, for the purposes of the corporation, moveable and immoveable property, hereditaments, life-rents, constituted rents, public securities, and generally all property moveable and immoveable whatsoever, either as owner or in trust, the value of the immoveables not to exceed three hundred thousand dollars. Power to possess, &c., property, &c. Value of immoveable property, limited.

It may also sell, hypothecate, alienate, assign, transfer, lease, or exchange all its moveable and immoveable property, or otherwise dispose of the same by any title whatsoever, and borrow all sums of money whatsoever for the purposes of the corporation. Power to sell, &c., its property, and to borrow money.

**7.** The corporation shall have the possession, enjoyment and administration of all property or articles whatsoever Certain property vested in corporation.

given or bequeathed or which may hereafter be given or bequeathed for the poor of the said parish of St. Joseph de Lévis and for other charitable purposes under any will or deed of gift.

Purposes of  
corporation.

**8.** The corporation may devote itself to such occupations as may be calculated to aid it in maintaining itself and carrying on the various works connected with its constitution, such as the care of the aged poor and infirm of both sexes, orphan asylums, schools of house-keeping, the care of idiots and insane of both sexes, and the receiving ladies or lay boarders who wish to live in their establishment.

Cemetery.

**9.** The corporation may have its cemetery on its property for the mortal remains of its members and patients, provided it complies with the laws, provisions and regulations enacted by civil authority.

**10.** The corporation shall be bound, whenever required, to make to the Lieutenant-Governor such report as he may exact.

**11.** This act shall come into force on the day of its sanction.

## CHAP. 119

An Act to incorporate the Murray Bay Convalescent Home

[Assented to 25th April, 1903]

Preamble.

**WHEREAS** the persons hereinafter mentioned have, by petition, represented that they and others for some years past, have maintained by voluntary contributions a certain institution at Pointe au Pic, Province of Quebec, known as the Murray Bay Convalescent Home, for the purpose of furnishing a home for convalescents, and have prayed that, for the better attainment of the objects of the said institution, the same may be vested with corporate powers; and whereas it is expedient to grant their prayer;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:
