C H A P . 1 3 8

An Act to extend, in favor of Herbert Molesworth Price, all the rights and privileges granted to George Benson Hall by the act 38 Victoria, chapter 98

[Assented to 25th April, 1903]

Preamble.

WHEREAS Herbert Molesworth Price, of Montmorency, has, by his petition, represented, that he is the assignee of all and every the rights and privileges granted to George Benson Hall by the act 38 Victoria, chapter 98, as appears by declaration before J. G. Couture, notary, at the city of Quebec, on the 30th of January, 1903, and that such act will expire on the twenty-third day of February, 1905 ;

Whereas he has prayed that the rights and privileges, so granted to George Benson Hall, be extended in his favor for a period of thirty years from the twenty-third day of February, 1905, and it is expedient, in the interest of persons engaged in lumbering on the Chaudiere River and its tributaries, to grant the request contained in such petition ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

Privileges under act 38 V., c. 98, conferred upon H. M. Price, and act extended for thirty years from 23rd Feb., 1905.

1. All the rights and privileges, granted to the said George Benson Hall by the act 38 Victoria, chapter 98, are hereby extended, in favor of Herbert Molesworth Price, of Montmorency, for a period of thirty years from the twenty-third day of February, 1905 ; and, from and after such date, the said Herbert Molesworth Price, his heirs and assigns, shall be authorized to enjoy all the rights and privileges granted by the said act to the said George Benson Hall, in the same manner and to the same effect as if the said act were again passed for another period of thirty years as aforesaid, and as if the name of the said Herbert Molesworth Price were substituted for that of the said George Benson Hall, wherever it appears in the said act.

2. The said Herbert Molesworth Price shall, from and after the twenty-third day of February, 1905, and throughout the duration of the said act, be subject to all the obligations imposed by the said act upon the said George Benson Hall.

H. M. Price to be subject to all obligations heretofore imposed upon G. B. Hall.

3. This act shall come into force on the day of its sanction.

CHAP. 139

An Act to authorize the Bar of the Province of Quebec to admit Joseph Adélaré Provencher amongst its members after examination

[Assented to 25th April, 1903]

WHEREAS Joseph Adélaré Provencher has, by petition, represented :

Preamble.

That he followed a course of studies, but was unable, for private reasons, to comply with the requirements of the law respecting the indentures and admission to the study of law ;

That, from January, 1897, to April, 1898, he studied in the office of François Siméon Tourigny, advocate and King's Counsel, practising in the city of Three Rivers ;

That he has filled the office of deputy prothonotary for nearly five years, and that of deputy clerk of the Crown for one year, in Three Rivers, and as such has acquired sufficient legal knowledge to entitle him to be admitted to the Bar, in addition to considerable experience in the procedure required for the practice of law ;

That, through his studies and experience, he possesses all the necessary qualifications for a practising advocate, and is fully qualified to practise such profession, as established by the certificates produced ;

That, as deputy prothonotary, he is constantly in communication with practising advocates, and is frequently called upon to interpret the provisions of the Civil Code and the Code of Civil Procedure, and that, without the title of advocate, he does not possess the necessary standing to give weight to the decisions he has to render ;

That all the members of the Bar of the section of Three Rivers have approved of the passing of an act authorizing the Bar of the Province of Quebec to admit him amongst its members, after examination, although he has not been regularly admitted to study ;

That he is prepared to pay the students' and practitioners' fees before presenting himself for examination ;
