

CHAP. 143

An Act to authorize the College of Physicians and Surgeons of the Province of Quebec to admit Georges Côté to the practice of medicine and surgery.

[Assented to 25th April, 1903]

Preamble.

WHEREAS Georges Côté, doctor of medicine, of the parish of St. Paul de Chester, county of Arthabaska, has, by his petition, represented :

That he attended all the lectures of the medical faculty of Laval University in Montreal for four years, and obtained a diploma of doctor of medicine, in June 1902 ;

That he began studying medicine before having obtained his certificate of admission to the study of medicine ;

That he was unable for private reasons to present himself for examination for admission to the study of medicine, after having attended a commercial course in Boston and the classical studies at the University of Ottawa, with the *Pères Oblats*, as far as the class of rhetoric ;

That, on account of his not being duly admitted to the study of medicine, he is exposed to lose the benefit of several years of medical studies ;

That, before following the medical lectures at Laval University at Montreal, he studied pharmacy in a druggist's establishment for three years, and moreover studied for four years in an hospital ;

That at present there is no physician practising medicine and surgery in the parish of St. Paul de Chester, and it appears by petitions signed by over five hundred residents and rate-payers of the parishes of St. Paul de Chester, St. Christophe d'Arthabaska, Ste. Anne de Fecteau's Mills, of the township of Ham North and of the parish of St. Rémi de Tingwick, that a considerable number of the residents of the said parishes ask that the College of Physicians and Surgeons of the Province of Quebec be authorized to grant the petitioner the necessary license for the practice of his diploma of doctor of medicine from Laval University ;

Whereas he has, by petition, prayed that an act be passed to that effect, and it is expedient to grant such prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly, of Quebec, enacts as follows :

Admission of
G. Côté as
physician.

1. The College of Physicians and Surgeons of the Province of Quebec is authorized to admit Georges Côté and to grant him the necessary license to practise medicine, surgery and

obstetrics in this province, after passing the examination for admission to practice.

2. This act shall come into force on the day of its sanction. Coming into force.

CHAP. 144

An Act to authorize the College of Physicians and Surgeons of the Province of Quebec to admit J. Alfred Dauth amongst its members

[Assented to 25th April, 1903]

WHEREAS J. Alfred Dauth, physician and surgeon, of Preamble.
the city and district of Montreal, has, by petition, represented :

That, on the 30th May, 1902, the president, secretary and the professors of the Montreal School of Medicine and Surgery, the medical faculty of Laval University, gave their certificates establishing that the petitioner had followed the course of lectures, that he had successfully passed the examinations and fulfilled all the conditions imposed by such faculty for obtaining the degree of doctor of medicine ;

That, on the 6th June last, 1902, Laval University, under the signature of its rector and under its seal, issued a diploma, conferring upon the petitioner the degree of doctor in medicine, with all the privileges, rights and powers thereto belonging ;

That the College of Physicians and Surgeons of the Province of Quebec states that it is unable to grant the petitioner a license to practise the profession of physician and surgeon in this province, because he has not passed the necessary examination for admission to the study of medicine ;

That the petitioner has followed the classical course of the seminary of St. Hyacinthe from the latin elements to the middle of the class of belles-lettres, and, under professors A. Leblond de Brumath and A. Bonin, he has studied all the subjects taught in the classes of rhetoric and philosophy in the colleges of this province ;

That, owing to ill-health and particular circumstances beyond his control, he was unable to pass the examination required for admission to the study of medicine ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. The College of Physicians and Surgeons of the Province of Quebec is authorized to admit G. Alfred Dauth and to grant him the necessary license to practise medicine, surgery and obstetrics in the province, after passing the examination for admission to practice. Admission of J. A. Dauth as physician.

2. This act shall come into force on the day of its sanction. Coming into force.
