

# ORDER IN COUNCIL



## EXECUTIVE COUNCIL CHAMBERS

QUEBEC, 18th May, 1903.

PRESENT : The LIEUTENANT GOVERNOR in Council.

Under the authority of article 4752 R. S. P. Q., it is ordered that items 17, 18, 19, 20 and 21 of the tariff of the Department of the Provincial Secretary and Registrar, established by order in council of the 27th of April, 1892, and amended by orders in councils of the 3rd of December, 1892, of the 3rd of September, 1896, and of the 19th of May, 1899, be replaced by the following, to wit :

“ No. 17.—On letters patent incorporating joint stock companies, when the capital is \$20,000 or less than \$20,000, the fee will be \$40.00.

No. 18.—When the capital is more than \$20,000, and less than \$50,000, the fee will be \$130.00.

No. 19.—When the capital is \$50,000 or more, and less than \$100,000, the fee will be \$180.00.

No. 20.—When the capital is \$100,000 or more, and less than \$150,000, the fee will be \$200.00.

No. 21.—When the capital is \$150,000 or more, and less than \$200,000, the fee will be \$225.00.

No. 21a.—When the capital is \$200,000 or more, and less than \$300,000, the fee will be \$275.00.

No. 21b.—When the capital is \$300,000 or more, and less than \$400,000, the fee will be \$300.00.

No. 21c.—When the capital is \$400,000 or more, and less than \$500,000, the fee will be \$325.00.

---

*Fees on letters patent of incorporation*

---

No. 21d.—When the capital is \$500,000 or more, and less than \$600,000, the fee will be \$350.00.

No. 21e.—When the capital is \$600,000 or more, and less than \$700,000, the fee will be \$375.00.

No. 21f.—When the capital is \$700,000 or more, and less than \$800,000, the fee will be \$400.00.

No. 21g.—When the capital is \$800,000 or more, and less than \$900,000, the fee will be \$425.00.

No. 21h.—When the capital is \$900,000 or more, and less than \$1,000,000, the fee will be \$450.00.

No. 21i.—When the capital is \$1,000,000, the fee will be \$500.00.

No. 21j.—For every million dollars of additional capital, or fraction thereof, the fee will be \$100.00.

No. 21k.—When application is made to increase the capital, the fee will be calculated on the actual amount of the increase in question, and the fee payable will be the same as that payable on letters patent for the incorporation of a company whose capital is of the same amount as the said increase.

No. 21l.—On applications for supplementary letters patent, other than those for the increase of capital, the fee will be 50% of the amount required as the fee for the incorporation.

For incorporating by letters patent city or town municipalities, in virtue of the statute 3 Edward VII, chap. 38 :

No. 21m.—On letters patent incorporating town municipalities, \$150.00.

No. 21n.—City municipalities, \$250.00.

With moreover, in both cases, the cost of publishing the notices and letters patent in the *Quebec Official Gazette*."
