

" 48. Licenses for the sale by wholesale of intoxicating liquors are granted, in municipalities governed by the Municipal Code, in the same manner, upon the same conditions, and with the same formalities as retail liquor licenses, as determined in the preceding article, and are subject to the provisions of articles 561 and 563 of the Municipal Code."

8. Article 51 of the said act is replaced by the following :

" 51. Bottlers' licenses are issued, in municipalities governed by the Municipal Code, in the same manner, upon the same conditions, and with the same formalities as retail liquor licenses, as determined in article 47, and are subject to the provisions of articles 561 and 563 of the Municipal Code."

9. Article 200 of the said act is amended by adding thereto the words " by this act."

10. Article 324 of the said act is amended by replacing the words " not less than twenty nor more than one hundred dollars " in the fourth and fifth lines by the words " not less than ten nor more than sixty dollars."

## CHAP. 14

### An Act to amend the Quebec Game Laws

[Assented to 26th March, 1902]

HIS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. Paragraph 1 of article 1399 of the Revised Statutes, R. S., 1399, as enacted by the act 62 Victoria, chapter 24, section 1, is amended by replacing the words and figures : " first day of November, 1902," in the first and second lines, by the words and figures : " first day of November, 1905."

2. Subsection *b* of paragraph 1 of article 1400 of the Revised Statutes, as enacted by the said act and replaced by the act 1 Edward VII, chapter 12, section 2, is amended by replacing, in the French version, the words : " l'année suivante," in the fourth line, by the words : " la même année."

**3.** Article 1405 of the Revised Statutes, as replaced by the act 62 Victoria chapter 24, section 1, and amended by the act 1 Edward VII, chapter 12, section 5, is further amended by adding at the end of paragraph 1 the following words :  
“ and at the expiration of the said delay of fifteen days, the sale, exposure for sale and having in possession for the purposes of sale, of any animal or bird or any portion thereof, protected by the preceding articles, is prohibited, saving the provisions of article 1471*d*.”

## CHAP. 15

### An Act to amend the Quebec Mining Law

[Assented to 26th March, 1902]

**H**IS MAJESTY, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

**1.** Article 1443 of the Revised Statutes, as enacted by the act 55-56 Victoria, chapter 20, section 1, is replaced by the following :

Size of mining

metals;

“ **1443.** When it concerns superior metals no sales of mining concessions, containing more than four hundred acres in superficies, shall be made to the same person. The Lieutenant-Governor in Council has, nevertheless, the right to grant to any person, upon sufficient proof of his capital and resources, a larger extent of territory, but not to exceed one thousand acres.

For inferior  
metals.

When it concerns inferior metals, it shall be lawful for the Lieutenant-Governor in Council to determine for each mineral the extent of the mining concession which may be granted to the same person.”

**2.** Paragraph 2 of article 1444 of the Revised Statutes as enacted by the said act, is replaced by the following :

“ **2.** If for the mining of inferior metals, the price shall be fixed by the Lieutenant-Governor in Council.”
