C H A P. 85

An Act to grant certain powers to the New Richmond
Lumber Company, (Limited.)

[Assented to 26th March, 1902]

WHEREAS the New Richmond Lumber Company, Limited, incorporated by letters-patent, issued on the 14th of December, 1895, under the Great Seal of the Dominion of Canada, has by petition represented that it has purchased from the Government of the province of Quebec the right to build a dam on the Little Cascapedia river in the sixth, seventh or eighth range of the township of New Richmond, and to utilize the water to operate mills required for the manufacturing of pulp, paper, lumber and wood products, together with the ownership of the bed of the Little Cascapedia river on a length of four miles from the site of the proposed dam upwards, and all lands, now the property of the Crown, that might be flooded after the erection of a dam, either up or down the river, within a radius of one mile from lot number nineteen of the seventh range of the said township of New Richmond ;

Preamble.

Whereas the said company has further represented that, in order to carry out its purpose, it must be given the necessary powers to acquire, buy and expropriate the lands that might be flooded by the erection of such dam and the fulfilment of its agreement with the Crown, and has prayed for such powers ;

Whereas it is expedient to grant the prayer contained in the said petition ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. The New Richmond Lumber Company (Limited) may acquire, erect, maintain, build, operate and sell mills and dams required for the manufacture of pulp, paper, lumber and wood products, in the counties of Gaspé, Bonaventure, and Rimouski, and specially at New Richmond and Little Cascapedia.

Possess tim-
ber limits,
&c., and
carry on tim-
ber trade, &c. ;

2. The company shall have the right to possess, purchase, lease, operate and sell timber limits and timber ; carry on the lumber trade, and manage, build, purchase and own saw-mills, factories, pulp and paper mills and other plant and apparatus required for such purposes, throughout the above territory.

Manufac-
ture, &c.,
lumber, &c. ;

3. The company shall have the right to manufacture lumber and carry on trade therein in all its branches ; build, purchase, construct, lease and run in connection with such business, steamboats, barges and other vessels ; build, erect, construct and sell or lease houses, sheds and stores for its employees and others, and generally carry on the business of merchants and dealers in provisions and merchandise of all kinds.

4. The company may purchase, construct and maintain, with fish-ways therein, such dams, flumes and other structures, canals or water conduits as may be required for the purposes of its undertaking on the Little Cascapedia river, its tributaries and lakes, or in the bed of said rivers, and for such purposes it may enter upon and survey lots on the banks of the rapids or along such rivers, and erect all structures necessary for the improvement of water-powers and supplying water to the rapids, or at any places in such streams.

Sell surplus
water, &c.

5. The company may lease or sell the surplus water belonging to it which it cannot use or dispose of.

Coming into

6. This act shall come into force on the day of its sanction.
