

(j) The date, mode and conditions of the payment of the said shares ;

(k) All other matters and things consistent with the provisions of this act, including the conditions of the resignation of its members.

11. These by-laws when once adopted can be changed only by a decision of two thirds of the members of the corporation, after notice given at a previous meeting of the members of the corporation. Changing by-laws.

12. The assets and liabilities of the association mentioned in the preamble of this act, the *Corps Musicale de Temperance de Montréal*, shall in future be those of this corporation. Assets of certain association, &c.

13. The first officers of the corporation shall be elected in accordance with the by-laws to be adopted by it. By-laws to govern first election of officers.

14. The amounts already subscribed to the capital stock shall be deemed to have been so subscribed in accordance with the provisions of this act and of the by-laws adopted in virtue thereof. Amounts already subscribed.

15. This act shall come into force on the day of its sanction. Coming into force.

C H A P. 1 0 4

An Act to incorporate *La Maison des Étudiants*

[Assented to 26th March, 1902]

WHEREAS Eugène Lafontaine, advocate, King's counsel; Preamble.
 Frédéric Debarteh Monk, advocate, member of the House of Commons of Canada; Honoré Gervais, advocate, King's counsel; Victor Morin, notary; Joseph Théodule Cardinal, advocate; Louis Théophile Maréchal, advocate, Ernest Marceau, civil engineer; Emmanuel Persilier Benoit, physician; Emile Vanier, civil engineer; Godefroy Langlois, journalist, and Arthur Beauchène, journalist; all of Montreal, have, by their petition, represented that they have decided to form an association with the object of gathering students together in the interest of their studies, of establishing bonds of fellowship and brotherhood between the members of such association, in order to procure aid and assistance for every one and of working for the physical, intellectual and moral development of studious youth, and have to that end prayed to be incorporated under the name of "*La Maison des Étudiants*."

Whereas such an association would be of public utility, and it is expédient to grant their prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

Persons incorporated.

1. Eugène Lafontaine, Frédéric Debartch Monk, Honoré Gervais, Victor Morin, Joseph Théodule Cardinal, Louis Théophile Maréchal, Ernest Marceau, Emmanuel Persilier Benoit, Emile Vanier, Godefroy Langlois and Arthur Beauchène, and all other persons who may join them and become members of the association in accordance with the by-laws they may adopt, are incorporated under the name of *La Maison des Étudiants*, hereinafter called "the corporation."

Name.

Head office.

2. The principal place of business of the corporation shall be in Montreal.

Composition of corporation.

3. The corporation shall consist of :

- (a) Active members ;
- (b) Honorary members ;
- (c) Life members ;
- (d) Charter members.

Qualification of active members.

4. To be an active member it shall be necessary :

- (a) To produce a document establishing that the candidate is actually registered as a student of a faculty, school or establishment of superior education of the judicial district for the purposes of appeal at Montreal ;
- (b) To be proposed by two members of the corporation and to be accepted by the board of management ;
- (c) To pay the entrance fee and yearly subscription which shall be fixed by the by-laws.

Honorary members.

5. The following shall be honorary members *de jure* on their application :

- (a) The rectors and professors of universities of the province, the professors of any faculty or school, college or establishment of superior education of the judicial district for the purposes of appeal at Montreal ;
- (b) The active members who have passed the final examinations of the faculties or schools.

The board of management may further confer the title of honorary member upon any person applying for the same.

6. Honorary members shall pay a yearly subscription which shall be fixed by the by-laws or which may be left to themselves.

Annual subscription by honorary members.

7. Every active or honorary member may become a life member and be relieved from the yearly subscription by subscribing the amount fixed by the by-laws.

Who may become life members.

8. The above-mentioned promoters and all persons who shall subscribe the amount to be determined by the by-laws or shall give a like amount, shall receive from the board of management the title of charter members and their names shall be entered in a special register.

Charter members.

9. Every active or honorary member who does not pay his subscription shall be declared by the board of management to be no longer a member of the corporation, and every life or charter member who fails to carry out his engagements may likewise be declared to have forfeited his membership and loses all right to reimbursement ; saving however the right to be re-admitted on such conditions as may be imposed by the by-laws.

Expulsion of members.

Proviso.

10. The administration of all the affairs of the corporation shall be confided to a commission chosen in the manner provided by the by-laws, but, in so far as practicable, one third shall consist of active and two thirds of other members.

Administration of affairs.

The commission elects a council of management which shall manage the affairs directly or through committees and choose its officers who shall be the officers of the corporation. The council shall exercise all the rights and powers of the corporation, except as regards the alienation of immoveables, and shall render an account yearly at the general meeting.

Council of management.

Its duties, &c.

11. The means by which the corporation may attain its end, are :

How corporation attains its ends.

Journals or bulletins ;

Publications and essays ;

Conferences, lectures, exhibitions and the establishment of libraries ;

Games, physical exercises and sports ;

Loans and bursaries, as well as assistance of all kinds.

12. The corporation shall have all the powers and rights vested in ordinary civil and commercial corporations.

Corporate rights.

13. The above-mentioned promoters and first members of the corporation, shall draw up the by-laws necessary

and suitable for securing the carrying out of this act and the establishment and working of the corporation and, amongst other things, respecting the admission and conduct of members, their rights and privileges, as well as their being struck off and expelled when necessary, the selection of the committee, the number of its members, its composition and the representation of groups of members, the qualifications required to vote and to be eligible, the elections, including the manner of holding the same, the government of the corporation, discipline and order, the management and administration of its property, the council of management, its attributions, its composition and the manner of its appointment, the appointment of officers and committees, their powers, duties and meetings, and, generally, all and every the objects and means above-mentioned.

Coming into
force.

14. This act shall come into force on the day of its sanction.

CHAP. 105

An Act to incorporate The City of Montreal Bakers' Benevolent Association

[Assented to 26th March, 1902]

Preamble.

WHEREAS Médard Paquette, Horace Normandin, E. Laflamme, Louis Brouillet, A. Lord and others, of the Bakers' Union of the city of Montreal, have, by petition, represented :

That the said association has been formed with the view of mutual assistance in the event of the sickness or infirmity of its members and of providing certain indemnities for the widows and children of deceased members ;

Whereas they have, by their petition, prayed to be incorporated, and it is expedient to grant their prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

Persons in-
corporated.

1. Médard Paquette, Horace Normandin, E. Laflamme, Louis Brouillet, A. Lord, Argenas Goyer, E. Comartin, H. Coursol, J. S. Prud'homme, F. Sanche, and all other persons who are now or may hereafter become members of the said association, shall be and are hereby constituted a body politic under the name of "The City of Montreal Bakers' Benevolent Association," and, under such name, may exercise
