

## C H A P. 119

An Act to authorize the Board of Notaries of the Province of Quebec to admit Percy Clare Duboyce to practise the notarial profession after examination

[Assented to 26th March, 1902]

Preamble.

**W**HEREAS Percy Clare Duboyce, notarial student, residing in the city of Montreal, has, by petition, represented :

That he has been a Bachelor of Arts of McGill University since the thirtieth day of April, eighteen hundred and ninety-seven.

That, previous to the passing, in 1899, of the act 62 Victoria, chapter 34, the general meetings of the Board of Notaries were held on the first Tuesday of September in each year, in virtue of the act 55-56 Victoria, chapter 31 ;

That, by the said statute 62 Victoria, chapter 34, the date of the general meetings of the Board of Notaries was changed to the second Tuesday of the month of July in each year ;

That the said Percy Clare Duboyce was credibly informed and believed that no change had taken place in the date of said meetings, and therefore did not give notice of his application to be admitted to the study of said notarial profession until about the first of August, 1899, when he was informed as to the change in the date of said meetings ;

That he has been a notarial student at Laval University, of Montreal, since the sixth day of September, 1899, and will graduate and receive from the said University the degree of Bachelor of Laws in the month of June, 1902 ;

That, from the twenty-third of September, 1899, he has studied in the office of John Fair, notary, at Montreal, as per indenture of that date, and that he will complete his three years' studentship in the month of September next, (1902) ;

That, on the eleventh of July, 1900, he was regularly admitted to the study of the notarial profession at the regular meeting of the Board of Notaries of the Province of Quebec, and did then pass new indentures with the said John Fair ;

That, for the above-mentioned reasons, it will be impossible for the said Percy Clare Duboyce to present himself before the Board of Notaries until the month of July, 1903, if the time of his studentship is counted only from the date of his second indenture, although he has really been under indenture since the twenty-third of September, 1899 ;

That it is consequently necessary that the Board of Notaries of the Province of Quebec be authorized to admit him to practise the said profession as if he had been under regular indentures since the twenty-third of September, 1899 ;

That the said board has, by an authorization passed at their general meeting held on the tenth of July, 1900, consented to the passing of the present act ;

Whereas the said Percy Clare Duboyce has prayed that an act to that effect be passed, and it is expedient to grant his prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

**1.** The Board of Notaries of the Province of Quebec is authorized to admit the said Percy Clare Duboyce to the final examination for admission to practise the notarial profession, upon production of a diploma conferring upon the said Percy Clare Duboyce the degrees of the Law Faculty of Laval University and of a certificate from said John Fair, showing that the said Percy Clare Duboyce has attended his office during three years, and, after satisfactory examination, to admit him to practise the said profession.

## C H A P. 1 2 0

An Act to authorize Joseph-Antoine Germano to practise  
the notarial profession in this province

[Assented to 26th March, 1902]

**W**HEREAS Joseph-Antoine Germano of the city of Montreal has, by his petition, represented :

Preamble.

That he practised the notarial profession in France for twenty-eight years, as attested by the certificate given him by the President of the Board of Notaries of Aix, in Provence, which certificate is annexed to the record ;

That, since his arrival in Canada on the 2nd February, 1888, that is to say, for the past fourteen years, the petitioner has constantly been connected with the notarial profession, and has never ceased to be employed as drafting clerk in important offices in Montreal ;
