

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Admission of
L. Savard as
notary.

1. The Board of Notaries of the Province of Quebec is authorized to admit Louis Savard to the final examination for admission to the practice of the notarial profession, upon presentation of a diploma of Bachelor in Law from Laval University, and of certificates showing that he has served a four years' clerkship.

Coming into

2. This act shall come into force on the day of its sanction.

C H A P. 1 2 3

An Act to authorize the College of Physicians and Surgeons of the Province of Quebec to admit Napoléon Landry as a physician and surgeon

[Assented to 26th March, 1902]

Preamble.

WHEREAS Napoléon Landry, physician and surgeon, heretofore of the town of St. Henri, district of Montreal, and now of Sarsfield, in the Province of Ontario, has, by his petition, represented:

That he obtained his diploma as physician and surgeon from Laval University, Montreal, after duly following the regular course of lectures of the said university;

That he began to follow the course of lectures of the said university before obtaining his certificate of admission to the study of medicine;

That he is qualified to practise medicine and surgery;

That he cannot at present obtain his license to practise medicine and surgery without special authority from the Legislature;

Whereas he has prayed for the passing of an act declaring that he shall hereafter be a member of the College of Physicians and Surgeons of the Province of Quebec, and authorizing the said college to grant him the necessary license for the practice of his profession.

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows:

Admission of
N. Landry as
physician.

1. Napoléon Landry, physician and surgeon, heretofore of the town of St. Henri, district of Montreal, and now of Sarsfield, in the Province of Ontario, is declared to be a

member of the college of physicians and surgeons of the Province of Quebec, which is authorized to grant him the necessary license for the practice of medicine, surgery and obstetrics in this province from the day of the sanction of this act, provided he passes the examination required for admission to practice.

2. This act shall come into force on the day of its sanction. Coming into force.

CHAP. 124

An Act to authorize the College of Physicians and Surgeons of the Province of Quebec to admit William Charles Mills to the practice of medicine and surgery

[Assented to 26th March, 1902]

WHEREAS William Charles Mills, formerly of the city and district of Montreal, but presently of Chateauguay, in the State of New York, one of the United States of America, has, by his petition, represented : Preamble.

That, in the month of April, 1893, he received from McGill University in the city of Montreal, the degree of Doctor of Medicine and Master of Surgery.

That, previous to receiving the said degree, he had passed a course of studies in the institution known as the Senior School of Montreal, and had further pursued his studies under the tuition of J. W. Tucker, B. A., and had passed the matriculation examination of McGill University for the undergraduate course in medicine ;

That he neglected, while a medical student, to obtain from the College of Physicians and Surgeons of the Province of Quebec a certificate of admission to study ;

That, in the year 1893, the Illinois State Board of Health conferred upon him a certificate of graduation, and, in 1894, the University of the State of New York granted to him a license to practise medicine and surgery in the State of New York, under which he has ever since practised the medical profession in the said State of New York ;

That personal and family reasons urgently require that he should reside in the city and district of Montreal, where he is desirous of taking up the practice of his profession ;

And whereas he has prayed, by his petition, that an act be passed to authorize the College of Physicians and Surgeons of the Province of Quebec to admit him among its members and to grant him a license to practise his profession in this province ;
