Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. The Dental Association of the Province of Quebec is hereby authorized to grant the said Joachim Reid a license certificate as surgeon-dentist in this province with all the privileges connected therewith, on presentation of his diploma of Doctor of Dental Surgery.

## CHAP. 128

An Act to allow Eugène-Alexandre Dorion to add the words " de St-Ours " to his family name

[Assented to 26th March, 1902]

WHEREAS Eugène-Alexandre Dorion, agriculturist, has, by petition, represented :

Preamble.

That he is the sole grandchild of the late Roch de St-Ours last seignior of St-Ours ;

That he is the only son of the late Honorable Joseph-Adolphe Dorion, in his lifetime, legislative councillor for the Division of Saurel, and of his wife Dame Amélie de St-Ours ;

That the said Dame de St-Ours is the sole survivor of the children of the late Roch de St-Ours, and that she is one of the co-proprietors of the former seignior of St-Ours, which her ancestors have held since 1672 ;

Whereas the said Eugène-Alexandre Dorion, presumptive heir to the said Dame Amélie de St-Ours, has, by petition, expressed the wish to change his name to that of Eugène-Alexandre Dorion de St-Ours, and has prayed that an act be passed for such purpose, and whereas it is expedient to grant his prayer ;

Therefore, His Majesty, with the advice and consent of the Legislative Council and of the Legislative Assembly of Quebec, enacts as follows :

1. The said Eugène-Alexandre Dorion shall hereafter be designated and known under the name of "Eugène-Alexandre Dorion de St-Ours," and, under such latter name, he may

claim, exercise and possess all the advantages, benefits, rights and titles which, without such change of name, he would be entitled to claim, exercise or possess ; and all contracts, bargains or agreements, entered into or made by him, by and under the name of Eugène-Alexandre Dorion, shall enure to his benefit and shall bind him and be considered as having been entered into and made by and under the name of Eugène-Alexandre Dorion de St-Ours ; and all legacies or gifts by will made in his favor, under the name of Eugène-Alexandre Dorion, shall enure to his benefit in the same manner as if the name of Eugène-Alexandre Dorion de St-Ours had been mentioned therein ; and he may also, under the latter name, recover, hold and possess and be capable of inheriting any property, moveable or immoveable, and rights of any nature or kind whatsoever, which he may at present have, hold or possess, or which he may hereafter inherit, or which he may recover, hold or possess, as fully and entirely as if the change of name had not been made by this act.

**2.** All rights and privileges generally whatsoever and of whatever nature they may be, now acquired by the said Eugène-Alexandre Dorion de St-Ours by this act, or which he may hereafter acquire, shall apply to his children and descendants.
