ORDERS IN COUNCIL



EXECUTIVE COUNCIL CHAMBERS

Quebec, 1st June, 1901

PRESENT :

THE LIEUTENANT-GOVERNOR

In Council

Whereas, under article 1415 of the Revised Statutes of Quebec, as enacted by the act 62 Victoria, chapter 24, persons not domiciled in the Province of Quebec cannot hunt therein without taking out the licenses required by the said article 1415 ;

Whereas a great many persons from the Province of Ontario and from the United States belong to fish and game clubs, incorporated under our Fishery and Game laws, and, after being thus incorporated, lease hunting territories in the province for which they pay a considerable yearly rent ; whereas consequently the persons so incorporated pay fees for permits to hunt in the Province of Quebec in the shape of annual rent ;

Whereas it has become necessary for the proper administration of hunting that a regulation be adopted to the effect that the certificate of membership given by the president and secretary of a fish and game club, duly incorporated under the law, and being the lessee of a hunting territory in this province, shall be equivalent to a hunting license granted under article 1415 aforesaid, but for hunting in the territory under lease only, when such certificate shall be given to a person not domiciled in this province and who is a *bonâ fide* member of such club.

Regulation respecting hunting

It is therefore ordered that the following regulation be passed and published according to law :

The certificate of membership given by the president and secretary of a fish and game club, being the lessee of a hunting territory in this province, to a *bonâ fide* member of such club, shall be equivalent to a hunting permit such as required by article 1415 of the Revised Statutes of Quebec, as enacted by the act 62 Victoria chapter 24, in the event of such member not being domiciled in the Province of Quebec, but such permit shall not entitle him to hunt outside the territory leased to the club whereof he is such *bonâ fide* member.

Incorporation of Fish and Game Clubs

In Council

Whereas it is expedient to consolidate the various Orders in council fixing the fee for the incorporation of fish and game clubs ;

It is therefore ordered that Orders in council No. 478 of the 9th September, 1892, and No. 58 of the 26th January, 1894, be repealed, and that Order in council No. 198 of the 5th June, 1885, be amended so as to read as follows :

In future the fee for the incorporation of a fish and game club shall be \$50.00. Nevertheless in the case of persons domiciled in one of the counties of this province wherein the operations of the fish and game club are to be carried on, the fee shall be \$25.00.

Price of hunting permits

EXECUTIVE COUNCIL CHAMBERS

THE LIEUTENANT-GOVERNOR

In Council

Ordered that all Orders in council respecting the price to be paid for hunting permits given to persons who are not domiciled in the Province of Quebec, hitherto passed, shall be repealed, and that in future the following rates will be charged for such permits :

1. \$25.00 for every person not domiciled in the Province of Quebec or in the Province of Ontario.
2. \$15.00 for every person domiciled in the Province of Ontario.
3. \$1.50 per diem for every person not domiciled in the Province of Quebec, hunting or shooting in this province for a few days only.
