### CHAP. 90

An Act to incorporate the Association of Butchers and  
Pork dealers of Quebec

[Assented to 23rd March, 1900]

**W**HEREAS Isidore Caouette, Paul Pouliot, Jean Drolet Preamble.  
and others have, by their petition, represented that an  
association exists under the name of "The Association of  
Butchers and Pork Dealers of Quebec," whose object is to  
protect the trade carried on by its members, to secure to  
them certain pecuniary advantages in case of sickness, and  
to secure also certain pecuniary advantages to the widows  
and heirs of deceased members ;

That the petitioners have prayed, by their petition, to be  
incorporated, and whereas it is expedient to grant their  
prayer ;

Therefore, Her Majesty, by and with the advice and con-  
sent of the Legislature of Quebec, enacts as follows :

1. Isidore Caouette, Paul Pouliot, Jean Drolet, Joseph Persons in-  
Paquet, Thomas Delany, John Martin, François Xavier corporated  
Bruneau, Joseph Belanger, Napoléon Dussault, Solyme Tur-  
cotte, Thomas Déchène and all the other members of the  
said association, as well as all those who may in the future  
become members, are hereby incorporated, under the name Name.  
of the "Association of Butchers and Pork Dealers of  
Quebec."

General powers.

**2.** The corporation may contract and bind itself; acquire and possess moveable and immoveable property, by gratuitous or onerous title, *inter vivos* or by will, the annual value of which immoveable property shall not exceed one thousand dollars; exchange, sell, alienate and hypothecate the property acquired or to be acquired by the said association, and loan or borrow on municipal, provincial or federal securities or other hypothecary security.

Board of directors.

**3.** There shall be a board of directors which shall manage and administer the affairs of the corporation, which shall be elected at the first general meeting convened by the present petitioners, and such board shall have power to make, amend and repeal all statutes, by-laws and regulations which may be judged necessary to carry out the intentions of this act, provided they be not contrary to law; but such by-laws and all changes made thereto shall be adopted by a majority of two-thirds of the members present at a general meeting.

Assistance to members, &c.

**4.** The corporation shall have the right to assist its sick members, the heirs and widows of deceased members, in whatsoever manner it may deem advisable, by by-laws which it shall make for that purpose.

Share may be bequeathed.

**5.** Any member shall have the right to bequeath by will to whomsoever he may choose, his share in the assets and revenues of the society; and no sum due by the corporation under the preceding clause to its members or their heirs or representatives shall be liable to seizure.

Not liable to seizure.

Head office.

**6.** The principal place of business of the corporation shall be in the city of Quebec.

Coming into force.

**7.** This act shall come into force on the day of its sanction.
