An Act to reorganize the Departments.

[Assented to 9th January, 1897.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. Article 143 of the Revised Statutes is amended, by striking out the words : " President of the Executive Council," in the second line, and by replacing the words : " Commissioner of Crown Lands, Commissioner of Agriculture and Colonization," in the third and fourth lines, by the words :

"Commissioner of Agriculture, Commissioner of Lands, Forests and Fisheries, and Commissioner of Colonization and Mines."

2. Article 143 of the said Revised Statutes, as amended by the preceding section, shall apply to the present members of the Executive Council, who may be called upon to occupy any of the positions created by this act. R. S., 143, to apply to present members of Executive Council.

3. Article 593 of the said Revised Statutes is replaced by the following : R. S., 593, replaced.

" **593.** The Lieutenant-Governor may appoint, under the Great Seal of the Province, from among the members of the Executive Council, the following functionaries, who remain in office during pleasure, that is to say : Members of Council and their titles.

1. An Attorney-General ;
2. A Provincial Secretary ;
3. A Provincial Treasurer ;
4. A Commissioner of Public Works ;
5. A Commissioner of Agriculture ;
6. A Commissioner of Lands, Forests and Fisheries.
7. A Commissioner of Colonization and Mines.

4. The following article is added after article 594 of the said Revised Statutes : Art. added after R. S., 594.

" **594a.** The Lieutenant-Governor in Council may define the duties to be exercised by any member of the Executive Council and transfer one or more branches of any department from the control of one member of the Executive Council to the control of any other member." 3. Fisheries on the banks of rivers, streams, and lakes in the Province, and all fisheries within the jurisdiction of the Province, are under his control;

4. The carrying out of the game laws is also under his supervision;

5. He administers the property of the Jesuits' Estates, Crown Domain, and of the Seignior of Lauzon. R. S., 1237.

“**1238.** The Commissioner annually lays before the Legislature, within ten days after the beginning of each session, a report of the proceedings of the Department during the year then next preceding. R. S., 1238.

“**1239.** He causes lists of the public lands for sale in the several townships in the Province to be made out from time to time, and advertised and published as he deems most advisable for ensuring general information. R. S., 1239.

“**1240.** He shall transmit, as early as possible in each year, to the secretary-treasurer of every county municipality, a list of the public lands sold, granted, leased, appro-

priated or set apart to any person, or for which licenses of occupation have been granted in such county municipality, during the year next preceding, and for which no patents have issued.

Liability of such lands for taxes, &c.

Such lands shall be liable for the assessed taxes in the townships in which they respectively lie, from the date of such sale, license or appropriation; and the purchaser, at the sale of any such lands for taxes, shall, as heretofore, have in the lands so sold the same rights only as the person entitled to claim under the Crown at the time of such sale.

Notice of cancellation of sales, &c., to be given to secretary-treasurers and registrars; Effect as to taxes.

2. He shall, in like manner, apprise each such secretary-treasurer of the cancellation of any license of occupation, sale, grant, lease, location or appropriation, and the registrar of every county and registration division, of the cancellation of any patent of land within such county and registration division; from which time, until resold, leased, or regranted, the land affected shall cease to be liable to taxes. R. S., 1240.

SECTION II.

STAFF OF THE DEPARTMENT.

§ 1.—*Assistant Commissioner and other Officers.*

§ 2.—*Powers and Duties of Assistant Commissioner.*

His duties and powers.

“**1244.** Without prejudice to the control of the Commissioner, the assistant commissioner has the superintendence of the other officers, clerks, messengers or servants, and the general control of all the affairs of the Department; his orders shall be executed in the same way as those of the Com-

missioner himself, and his authority shall be deemed to be that of the head of the Department, so that he can validly affix his signature, in his said quality, and thereby give force and authority to all acts, receipts, permits of occupation, contracts or deeds of sale, location tickets, letters-patent, adjudications, revocations of sales or locations, and all other documents whatsoever, which are or may be within the jurisdiction of the Department.

2. It is lawful for the Lieutenant-Governor in Council, from time to time, whenever he may deem it expedient, to revoke, wholly or in part, the powers of the assistant commissioner. Revocation of powers.

3. Before entering on the duties of his office, the assistant commissioner shall take an oath faithfully to discharge the same. He shall be sworn.

Such oath is administered by the commissioner, or any person appointed by the Lieutenant-Governor for that purpose. Oath before whom taken. R.S., 1244.

“**1245.** The Lieutenant-Governor in Council shall require, from the assistant commissioner and from every agent appointed under him, security for the due performance of his duty. R S., 1245. Assistant commissioner and agent to give security.”

“**1246.** During the illness or absence of the assistant commissioner, the head of the Department shall appoint another officer to temporarily perform his duties ; and notice of such appointment shall be given in writing to each officer and clerk of the Department.” R. S., 1246. During his absence a substitute shall be named.

"**1586.** The functions, powers and duties of the Commissioner are the following :

1. He has, throughout the Province, the control and management of everything connected with agriculture ;

2. He has the control of and supervision over agricultural schools or colleges and model farms receiving Government grants, permanent exhibition committees, agricultural and horticultural societies and institutions for teaching agriculture ;

3. The council of arts and manufactures and mechanics' institutes, as well as beet sugar manufactories receiving Government grants, are under his control ;

Arts and manufactures.

4. The Dairy Association of the Province of Quebec, Compton Model Farm, Farmers and Dairymen's Associations, and societies for the manufacture of butter and cheese are bound to make an annual return of their operations to him. R. S., 1586.

Dairy Association, &c.

"**1586a.** There shall be attached to the Department a bureau to be called the "Bureau of Industries," for collecting, tabulating and publishing industrial information for public purposes, and the Commissioner shall have the direction thereof.

Bureau of Industries.

"**1587.** The Commissioner shall institute inquiries, collect useful facts and statistics relating to agriculture, mechanics and manufactures and adopt measures for circulating the same, with a view of promoting the progress of the Province and attracting foreign immigration. R. S., 1587.

Appointment of agricultural and other officers.

He may also, from time to time, appoint, outside of the Department, as many agricultural officers and other officers, whom he may deem necessary for the efficiency of the service in the various branches of the Department, and may remove them from office at pleasure.

Inspectors.

Persons may, at any time, be appointed by the Commissioner to inspect the books and accounts of any agricultural society receiving a Government grant or connected in any way with the Department.

Officers of societies to submit books for inspection.

The officers of every such society, whenever so required, shall submit such books and accounts to inspection, and truly and to the best of their knowledge answer all questions put to them in relation thereto or to the funds of such society. R. S., 1589, *in part*.

Other duties of officers may be assigned.

“**1590.** The respective duties of the officers of the Department, not expressly regulated by law, are from time to time assigned to them by the Commissioner. R. S., 1590.

§ 2.—*General Powers and Duties of the Officers of the Department.*

Control of assistant commissioner.

“**1591.** The assistant commissioner shall, subject to the control of the Commissioner, superintend and direct the other officers and servants of the Department.

General business.

2. He has the general control of the business of the Department, and has all the other powers assigned to him by the Lieutenant-Governor in Council.

Suspension of officers by assistant commissioner.

3. In the absence of the Commissioner, and during such absence, he may suspend any officer or servant of the Department who refuses or neglects to obey his orders. R. S., 1591.

He shall be sworn.

4. Before entering on the duties of his office, the assistant commissioner shall take an oath faithfully to discharge the same.

Such oath is administered by the Commissioner, or any person appointed by the Lieutenant-Governor for that purpose. R. S., 1244, *in part*. Oath before whom taken.

“ **1592.** Unless otherwise directed by the Commissioner, the secretary shall : Duties of secretary:

1. Conduct, under the direction of the Commissioner, the correspondence of the Department ; Conduct correspondence;
2. Keep a regular register of such correspondence, and classify the same in such a manner as to be able easily to refer thereto ; Keep register;
3. Prepare the reports ; Prepare reports ;
4. Keep separate accounts for the grants to which are entitled the council of agriculture, the council of arts and manufactures, the permanent exhibition committee, agricultural societies, and institutions for teaching agriculture ; Keep accounts for grants, &c.;
5. Keep proper accounts for the sums due to persons employed by the Department, or to any other persons ; Keep accounts with contractors, &c.;
6. Prepare certificates upon which any warrant is to issue ; Prepare certificates ;
7. Keep charge of all reports, maps, plans, contracts, titles, models and other articles and documents relating to arts and manufactures, agriculture and agricultural industries ; Have charge of reports, &c.;
8. Keep minutes of all proceedings of the Department ; Keep minutes of proceedings, &c. ;
9. Generally, perform all such acts concerning the business of the Department which he may, from time to time, be directed by the Commissioner to perform. R. S., 1592, *in part*. Other duties.

§ 3.—*Duties of Officers of certain Institutions respecting the Department.*

“ **1593.** Agricultural societies, colleges or schools of agriculture, the council of arts and manufactures, mechanics' institutes, public institutions, and public officers in this Province, shall promptly answer official communications from the Department, and shall make diligent efforts to supply correct information on all questions submitted to them. Institutions to answer official communications.

Any officer of any of the institutions above named, refusing or wilfully neglecting to answer any questions or to furnish any information relating to the interests of agriculture, agricultural institutions, mechanics or manufactures, shall for every such offence incur a penalty of twenty dollars, which shall be recoverable in the name of Her Majesty before any competent court of justice.” R. 7. Keep charge of all reports, maps, plans, contracts, titles, models or other articles and documents, relating to colonization, emigration and immigration ;

Keep minutes

8. Keep minutes of all proceedings of the Department ;

Other duties.

9. Generally, perform all such acts concerning the business of the Department which he may, from time to time, be directed by the Commissioner to perform. R. S., 1592, *in part*.

"1703k. The Lieutenant-Governor in Council shall require, from the assistant commissioner and from every agent appointed under him, security for the due performance of his duty. R. S., 1245.

Security to be furnished by certain officers.

"1703l. During the illness or absence of the assistant commissioner, the head of the Department shall appoint another officer to temporarily perform his duties; and notice of such appointment shall be given in writing to each officer and clerk of the Department. R. S., 1246.

During absence of assistant commissioner a substitute shall be named.

§ 3.—*Duties of Officers of certain Institutions respecting the Department.*

"1703m. Colonization societies shall promptly answer official communications from the Department, and shall make diligent efforts to supply correct information on all questions submitted to them.

Institutions to answer official communications.

Any officer of any of the institutions above-named, refusing or wilfully neglecting to answer any questions or to furnish any information relating to the interests of colonization, shall, for every such offence, incur a penalty of twenty dollars, which shall be recoverable, in the name of Her Majesty, before any competent court of justice." R. S., 1593.

Present offi-

27. The present officers of the Department of Agriculture and Colonization and of the Department of Crown Lands may, without any new appointment, continue to exercise their offices or may be transferred to other positions in any of the departments created by this act, at the pleasure of the Lieutenant-Governor in Council.

Coming into

28. This act shall come into force on the day of its sanction.

CAP. XXIII.

An Act to amend the Quebec License Law.

[Assented to 9th January, 1897.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

Pedlars de-
fined.

1. The following paragraph is added after paragraph 39 of article 828 of the Revised Statutes, as enacted by the act 59 Victoria, chapter 14, section 1:

"40. Any trader taking orders, and selling under such orders by retail and directly to the consumer, or outside of his shop or store, in rural municipalities, is considered to be a pedlar for the purposes of this section."
