

That, owing to the provisions of article 3824 of the Revised Statutes, he cannot be admitted to the examination for practice, and that a special authorization of the Legislature to that effect is necessary to enable him to do so ;

Whereas the Board of Notaries of the Province of Quebec approves of the passing of an act for that purpose ;

And whereas, by his petition, the said Elzéar Drolet has prayed that such act be passed, and it is expedient to grant his prayer ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

E. Drolet may be admitted to practise the notarial profession after examination.

1. The Board of Notaries of the Province of Quebec is authorized to allow Elzéar Drolet, notarial student, of Quebec, to present himself for the examination required by law to be admitted to practise the Notarial profession ; and, after such examination, to admit him amongst its members, and to deliver him a certificate of admission to practice.

Coming into force.

2. This act shall come into force on the day of its sanction.

#### CAP. CIV.

An Act to authorize the College of Physicians and Surgeons of the Province of Quebec to admit Théodule Alfred Lemieux amongst its members, after examination.

[Assented to 9th January, 1897.]

Preamble.

WHEREAS Théodule Alfred Lemieux, of Levis, medical student of Laval University, Quebec, has, by petition, represented :

That he studied veterinary medicine at the Quebec Veterinary School for three years, and received his diploma authorizing him to practise as a veterinary surgeon on the 1st April, 1892 ;

That from January, 1894, he again followed the course of medicine and surgery, as a medical student of Laval University ; and, during the said period of five years and a half, he has followed all the courses which form part of the curriculum of medicine and surgery, but that he was only two years and a half under indentures, which prevents him from obtaining his license from the college ;

Whereas he has prayed for the passing of an act enacting that he shall, after the necessary examination, form part of the College of Physicians and Surgeons of the Prov-

ince of Quebec, and authorizing the said college to grant him the license required for the practice of the profession, after examination ;

And whereas the said college does not oppose his petition, and it is expedient to grant his prayer ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. The College of Physicians and Surgeons of the Province of Quebec is authorized to grant to Théodule Alfred Lemieux, of the town of Levis, medical student, the license required for the practice of medicine, surgery and midwifery in the Province of Quebec, after the necessary examinations.

Admission of T. A. Lemieux as physician after examination.

2. This act shall come into force on the day of its sanction.

C A P. C V .

An Act to authorize the College of Physicians and Surgeons of the Province of Quebec to admit Joseph Hermenégilde Tremblay to the practice of medicine and surgery.

[Assented to 9th January, 1897.]

**W**HEREAS Joseph Hermenégilde Tremblay, medical student, of the city and district of Quebec, has, by petition, represented :

Preamble.

That he has followed a complete course of medicine at Laval University, in Quebec, for over three years, and will complete his medical studies there in March next, one thousand eight hundred and ninety-seven ;

That he commenced to follow the course of medicine before having obtained his certificate of admission to the study of medicine ;

That he has been unable, for private reasons, to present himself for examination to be admitted to the study of medicine ;

That he obtained the diploma of Bachelor of Medicine of Laval University, in Quebec, after having duly followed the regular courses in the said university ;

That the fact of his not having been regularly admitted to the study of medicine exposes him to lose the benefit of several years of medical studies :

That it is necessary that the College of Physicians and Surgeons of the Province of Quebec be authorized to grant him the license required for the practice of his profession in the Province of Quebec, after examination ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :
