## EXECUTIVE COUNCIL CHAMBERS.

Quebec, 26th February, 1896.

No. 78.

PRESENT :

The Lieutenant-Governor in Council.

RESPECTING the substitution of Durocher's improved ballot slip for the ballot now in use for the general elections.

WHEREAS, in virtue of article 135 of the Quebec Election Act, 1895, the Lieutenant-Governor in Council may, before the date fixed for the general elections which will follow the dissolution of this Legislature, order that the ballot-paper commonly known as "Durocher's improved ballot slip," made according to form OO, be, for the purposes of the said general elections, substituted to the ballot-paper now in use ;

Whereas the said article 135 further enacts that the order in council ordering the use of the Durocher's ballot slip shall be published in the *Quebec Official Gazette* for one month.

It is ordered that Durocher's improved ballot slip be substituted to the ballot-paper now in use for all legal purposes for the general elections which will follow the dissolution of the present Legislature of Quebec, and that the order in council to that effect be published in the *Quebec Official Gazette* for one month.

*Amendment of the Tariff of Fees.*

EXECUTIVE COUNCIL CHAMBERS.

Quebec, 3rd September, 1896.

PRESENT :

The Lieutenant-Governor in Council.

ON the amendment of the tariff of fees established by order in council No. 205 of 1892.

WHEREAS the Department of the Provincial Secretary and Registrar has, since the coming into force of the tariff of fees established by the order in council No. 205, dated the 27th April, 1892, had great difficulty in collecting the fees established by articles 16 (Secretary's office) and 1 (Registrar's office) of the said order in council, and it is expedient to amend the said articles of the said order in council ;

It is ordered that article 16 of the said order in council, which reads as follows : " Commission appointing to any other position under the Government of this Province, ten per cent of the salary allowed," be replaced by the following : " Commission appointing to any office under the Government of this Province and for which no fee is already fixed, \$5.00," and that article 1 (Registrar's office) of the said order in council be replaced by the following : "1. Registration of civil service commission, \$5.00."
