

of January, nineteen hundred and fifty-five, were substituted therefor ;

Whereas, under the authority of the first named act, 54 Victoria, chapter 2, there was borrowed a further sum of six hundred thousand pounds sterling, equal at par of exchange to two millions, nine hundred and twenty thousand dollars, for which the debentures of the Province were issued, bearing interest at the rate of four per cent per annum, dated the first of March, eighteen hundred and ninety-four, and payable on the first of March, nineteen hundred and thirty-four ;

And whereas doubts have arisen as to what amount remains to be borrowed of the ten millions of dollars authorized to be borrowed by the said act, 54 Victoria, chapter 2, and it is expedient to remove such doubts ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

Power to borrow \$3,220,000.00.

**1.** The Lieutenant-Governor in Council may, under the authority of the act 54 Victoria, chapter 2, procure by way of loan, from time to time, as the necessities of the Province may require, upon the terms and conditions stipulated in the said act, the sum of three millions, two hundred and twenty thousand dollars, or its equivalent in pounds sterling or francs, being the balance of the ten millions of dollars thereby authorized to be borrowed, after deducting the sum of three millions, eight hundred and sixty thousand dollars borrowed under date of fifteenth July, eighteen hundred and ninety-one, and the sum of two millions, nine hundred and twenty thousand dollars borrowed under date of first of March, eighteen hundred and ninety-four.

Coming into force.

**2.** This act shall come into force on the day of its sanction.

### CAP. III.

An Act to amend the act 58 Victoria, chapter 2, respecting railway subsidies.

[Assented to 21st December, 1895.]

**H**ER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

**1.** Paragraph 2 of section 5 of the act 58 Victoria, chapter 2, is amended by replacing the word : "six," in the second line, by the word : "twelve."

2. This act shall come into force on the day of its sanction. Coming into force.

C A P. I V .

An Act respecting the payment of a certain sum forming part of the subsidy granted by the act 49-50 Victoria, chapter 77.

[Assented to 21st December, 1895.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. The Order in Council number one hundred and fifty-two of the eleventh of May, eighteen hundred and ninety-five, contained in the annex of this act, is approved. Certain Order in Council approved.

2. It shall be lawful for the Lieutenant-Governor in Council to pay to John L. Reay (for the Bank of Montreal), the sum of two thousand dollars, together with an additional sum of seven hundred and forty-one dollars and seventy-three cents, for costs ; to Dame Caroline Têtu, widow of the late Henri Jules Juchereau Duchesnay, the sum of four thousand dollars ; to Cléophas Beausoleil, advocate and member of the House of Commons of Canada, the sum of two thousand five hundred dollars, the whole with interest from the eleventh of May, eighteen hundred and ninety-five. Certain sums authorized to be paid.

3. The aforesaid sums shall be taken out of the consolidated railway fund, that is to say, out of the seventy-three thousand, three hundred dollars and seventy-five cents, of the subsidy declared lapsed by the act 57 Victoria, chapter 5, section 4, and the schedule A thereto. Whence to be taken.

4. The Government shall have recourse against Charles N. Armstrong mentioned in the Order in Council, annexed to this act, and against the Great Eastern Railway Company for the sums paid under this act, and for the interest thereon from the time they are paid. Recourse of Government against certain persons reserved.

5. This act shall come into force on the day of its sanction. Coming into force.
