2. Article 1675*d* of the said Revised Statutes, as enacted by the said act, is amended by adding after the first clause the following :

Change of
club's name.

"It is lawful for the Commissioner of Agriculture, at any time, to change the name of a farmers' club, by a notice published in the *Quebec Official Gazette*."

CAP. XXII.

An Act to amend the law respecting agriculture, with reference to the Good Roads' Association of the Province of Quebec.

[Assented to 21st December, 1895.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

Arts. 1682*i* to
1682*o* added
to R. S.

1. The following subsection is added to the Revised Statutes, after the fourth subsection of section sixth of chapter seventh of title fourth :

§ 5.—*Good Roads' Association of the Province of Quebec.*

Organization
of association
by means of
declaration.

"1682*i*. Forty persons at least may organize and constitute themselves into a good roads' association of the province, by signing a declaration in the form of schedule A and subscribing an annual sum of at least eighty dollars to the funds thereof.

Declaration
how made and
published.

"1682*j*. Such declaration shall be made in duplicate, one copy of which shall be written and signed in a book to be carefully preserved by the association and the other sent immediately to the Commissioner, who shall, as soon as possible after its reception, publish a notice of the formation of such association in the *Quebec Official Gazette*.

Effect of pub-
lication.

"1682*k*. From and after the publication in the *Quebec Official Gazette* of the notice of the formation of such association, it becomes a body politic and corporate for the purposes and intents hereinafter mentioned, under the name of the "Good Roads' Association of the Province of Quebec," with all the powers inherent to corporations.

Name.

Power to
make by-laws
for certain
purposes.

"1682*l*. The association shall be empowered to make by-laws, not contrary to the laws of this Province nor to this subsection, to prescribe the mode of admission of new members, and to regulate the election of its officers and the administration of its affairs and property generally.

" **1682m.** The association shall, with a view of studying the proper means of improving the roads in this Province, hold a general meeting of its members each year at the times and places fixed by its by-laws. Annual general meeting.

At such meeting, it shall elect a president, a vice-president, a secretary-treasurer, and not less than three nor more than nine directors. Election of officers.

" **1682n.** The officers and directors shall prepare and submit to the meeting a detailed report of their operations, giving the names and addresses of its members, the amount subscribed and paid by each of them, together with the observations which may be of a nature to improve the roads in the Province. Annual report.

" **1682o.** The principal place of business of the association may be changed by the board of directors." Head office may be changed.

SCHEDULE A

MENTIONED IN ARTICLE 1682i.

We, the undersigned, agree to form ourselves into an association under the provisions of subsection fifth of section sixth of chapter seventh of title fourth of the Revised Statutes, under the name of the "Good Roads' Association of the Province of Quebec," our principal place of business to be at _____, and we hereby undertake to pay, respectively and annually, the sums opposite our names, to the secretary-treasurer, so long as we remain members of the association, and we further undertake to comply with the rules and regulations of the association.
