

CAP. XXXVII.

An Act to amend the special provisions respecting public schools in the cities of Montreal and Quebec.

[Assented to 21st December, 1895.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. Section 24 of the act 32 Victoria, chapter 16, is amended ^{32 V., c. 16,} by striking out, in the fourth and fifth lines, the words : ^{s. 24, amend-} " under the above provisions." ^{ed.}

2. Section 4 of the act 35 Victoria, chapter 12, is amended ^{35 V., c. 12,} by striking out, in the third, fourth, fifth and sixth lines, ^{s. 4, amended.} the words : " not to exceed, however, together with that already paid by the corporation for the same year, the sum to which either board would have been entitled under the act hereby amended."

CAP. XXXVIII.

An Act to amend the act 58 Victoria, chapter 45, respecting the tenure of lands in the Magdalen Islands.

[Assented to 21st December, 1895]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. Section 9 of the act 58 Victoria, chapter 45, is re- ^{58 V., c. 45,} placed by the following : ^{s. 9, replaced.}

2 Section 12 of the said act is amended by replacing the words : " a notice, fifteen days before the first day of the month during which the rent annually becomes due," in the fifth, sixth and seventh lines, by the words : " a notice of fifteen days."

3. Section 13 of the said act is amended by striking out the words : " upon which the rent becomes annually due," in the second and third lines.

4. The redemption effected and title given in execution thereof, under this act and the act hereby amended, shall not have the effect of giving the person effecting the same any rights to the mines which may be found in the immoveable so redeemed, other than those which he may have had in virtue of his original lease or concession.

All mines of gold, silver, copper, tin, lead, iron and coal, as mentioned in the letters-patent of the twenty-fourth April, seventeen hundred and ninety-eight, continue to be reserved in favor of the Crown, and the other mines are reserved in favor of the testamentary heirs of Sir Isaac Coffin, excepting those which he, or John Townsend Coffin, or Isaac Tristram Coffin, may have lawfully disposed of in favor of the occupants of the Islands, under their original leases or concessions.

An Act to amend the law respecting registers of marriages, baptisms and burials.
