

## C A P. L V I I .

An Act to amend the charter of the village of Senneville.

[Assented to 21st December, 1895.]

Preamble.

**W**HEREAS it has been represented by petition of the inhabitants of the village of Senneville,

That it was enacted by section 9 of the charter of the village of Senneville, 58 Victoria, chapter 60, that the first election of the mayor and councillors should be held on the thirteenth day after the coming into force of the act, thereby rendering it impossible to hold the said first election, and to give the notices required by law ;

Whereas they have prayed, by their petition, for an act to authorize the holding of the first election of mayor and councillors on some other day ; and it is expedient to grant the prayer of the said petition ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

**1.** Section 9 of the act 58 Victoria, chapter 60, is replaced by the following :

“ **9.** The first election of the mayor and councillors shall be held on the date and at the place fixed, and be presided over by the person appointed, by the Lieutenant-Governor.

**2.** This act shall come into force on the day of its sanction.

## C A P. L V I I I .

An Act to divide the municipality of the township of Clifton, in the county of Compton, into two separate municipalities.

[Assented to 21st December, 1895.]

Preamble.

**W**HEREAS a large number of the inhabitants of the township of Clifton, in the county of Compton, have, by petition, prayed that the township be erected into two distinct and separate municipalities, and it is expedient to grant the prayer of the said petition ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

Municipality  
divided.

**1.** The municipality of the township of Clifton shall cease in future to form only one municipality, and shall be divided into two distinct municipalities, which shall be

known and designated as the "municipality of the township of Saint Edwidge de Clifton," and the "municipality of the township of Clifton." Names of new municipalities.

2. The municipality of the township of Clifton shall comprise in future lots eighteen, nineteen, twenty, twenty-one, twenty-two, twenty-three, twenty-four, twenty-five, twenty-six, twenty-seven and twenty-eight of the seventh, eighth, ninth, tenth and eleventh ranges of the old municipality of the township of Clifton. Territory comprised in municipality of Clifton.

3. The municipality of the township of Saint Edwidge de Clifton shall comprise lots one, two, three, four, five, six, seven, eight, nine, ten, eleven, twelve, thirteen, fourteen, fifteen, sixteen and seventeen of the fifth, sixth, seventh, eighth, ninth, tenth and eleventh ranges of the old municipality of the township of Clifton. Territory comprised in municipality of Saint Edwidge de Clifton.

4. These two municipalities, respectively, so erected, shall be separate and distinct for all municipal and school purposes, and all the provisions of the Municipal Code shall apply to these municipalities, and also to the corporation and to the council of each, to the same extent and in the same manner as if they had been separated by virtue of the Municipal Code. Municipalities to be separate and to be governed by Municipal Code.

5. The municipal councillors for the present township of Clifton shall retain office until the election of new councillors, as hereinafter provided, when they shall retire from office. Present municipal councillors.

6. A meeting of the electors of the municipality of the township of Clifton shall be held in the said municipality, at the school-house in the village of Martinville, on the second Monday in the month of January next (1896), for the election of councillors, in accordance with the provisions of the Municipal Code. Election of councillors for municipality of township of Clifton.

Such meeting shall be presided over by any person at the said meeting chosen by the majority of the electors present. Who presides.

7. A meeting of the electors of the municipality of the township of Saint Edwidge de Clifton shall be held in the said municipality at the place where the meetings of the present council are held, on the second Monday in the month of January next, for the election of councillors, in accordance with the provisions of the Municipal Code. Election of councillors for municipality of St. Edwidge de Clifton.

Such meeting shall be presided over by any person at the said meeting chosen by a majority of the electors present. Who presides.

Notices calling meetings.

**8.** Public notices, in accordance with the provisions of the Municipal Code, of the said two elections, shall be given by the present secretary-treasurer of the township of Clifton.

Secretary-treasurer of St. Edwidge.

**9.** The present secretary-treasurer of the township of Clifton shall be the secretary-treasurer of the municipality of the township of Saint Edwidge de Clifton until his successor is appointed.

School commissioners of township.

**10.** The present board of school commissioners for the municipality of the township of Clifton shall be the school commissioners for the municipality of the township of Saint Edwidge de Clifton.

Property vested in them.

They shall own the school property situate within the limits of Saint Edwidge de Clifton, subject to the liabilities of the present school commissioners.

Present school trustees to continue in office.

**11.** The board of school trustees of the old municipality of the township of Clifton shall continue in office until a board of school commissioners for the municipality of the township of Clifton shall be elected to replace them.

Election of commissioners for Clifton.

On the first Monday in July next, a board of school commissioners shall be elected for the municipality of the township of Clifton, to replace the present board of school trustees, and they shall take over all the property of the said trustees and assume all their liabilities.

Division of assets, &c., of old municipality.

**12.** The moveable property, liabilities and assets of the present municipality of the township of Clifton shall be divided between the two new municipalities in conformity with the Municipal Code.

Coming into force.

**13.** This act shall come into force on the day of its sanction.

#### An Act to amend the charter of the Quebec Central Railway Company.

[Assented to 21st December, 1895.]

Preamble.

**W**HEREAS the Quebec Central Railway Company has, by its petition, represented that it is necessary to raise additional capital for the completion of its line from Tring to Lake Megantic, for additional equipment, for the acquisition of a deep-water terminus in or near the town of Levis, and for other purposes, and that increased bonding
