

Whereas, in order to assure all these facilities of communication to the public, two bridges had to be built over the Bécancour river ;

Whereas by section 2 of the act 46 Victoria, chapter 60, it is specially enacted that the rates of tolls to be levied on these two bridges shall be the same ;

Whereas the rates of toll on the said two bridges are insufficient to enable the owners of these bridges to give full and entire satisfaction to the public ;

Whereas the owners of these two bridges have prayed for the passing of this act, and it is expedient to grant their prayer ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. Section 5 of the act 46 Victoria, chapter 60, is amended by replacing the tariff therein as follows, to wit :

"For every vehicle drawn by two animals... ..	\$0 10

For every person on foot.....	0 01
For every horse or head of cattle not harnessed..	0 01

CAP. LXXVI.

An Act respecting the building of the Roman Catholic Church of the parish of *Sacré-Cœur de Jésus, Montreal.*

[Assented to 21st December, 1895.]

Preamble.

WHEREAS the trustees of the parish of *Sacré-Cœur de Jésus, Montreal*, have, by petition, represented :

That, at a meeting of the freehold inhabitants of the parish of *Sacré-Cœur de Jésus, Montreal*, duly convened and held on the fourth of November, one thousand eight hundred and ninety-five, it was resolved to prolong and extend the powers of the trustees of the parish of *Sacré-Cœur de Jésus, Montreal*, to enable them to levy sixteen cents per hundred dollars of the value of the real estate assessed which have not been collected by the said trustees in virtue of the powers conferred upon them by the act 49-50 Victoria, chapter 45 ;

Whereas a petition to that effect has been presented, and it is expedient to grant the same ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. The trustees of the parish of *Sacré-Cœur de Jésus*, Montreal, may, under the restrictions and conditions set forth in the act 49-50 Victoria, chapter 45, levy, if necessary, an amount not exceeding sixteen cents per hundred dollars of the value of the real estate as established by the valuation roll in force on the first of October, one thousand eight hundred and ninety-six, which said sixteen cents per hundred dollars were not collected by the said trustees, under the powers conferred upon them by the act aforesaid, to wit: ten cents per hundred dollars, deducted in eighteen hundred and ninety from the forty cents per annum per hundred dollars which the said act 49-50 Victoria, chapter 45, and the assessment based upon the said act allowed them to levy, and six cents per hundred dollars, deducted in eighteen hundred and ninety-four, from the forty cents per annum per hundred dollars which they could exact in virtue of the said statute and assessment.

Trustees authorized to levy certain tax, not heretofore collected under 49 50 V., c. 45.

2. The amount to be levied in virtue of the preceding section is payable in two half yearly and consecutive payments, the first whereof shall be due on the first of May, eighteen hundred and ninety-seven.

How tax to be payable.

3. This act shall come into force on the day of its sanction.

An Act to incorporate The Dominion College of Music, Montreal.
