

Whereas the petitioners have prayed that the powers necessary for the above purposes be conferred upon the corporation, and it is expedient to grant their prayer ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. Acquire, accept and receive, by any title, all moveable and immovable property, and may sell or otherwise dispose of the same, and exercise all the powers necessary for its purposes.

An Act to incorporate *L'Ecole de médecine comparée et de science vétérinaire de Montréal*, and to repeal the acts in- corporating The Montreal School of Veterinary Surgery, and The French Veterinary School of Montreal.

[Assented to 21st December, 1895.]

Preamble.

WHEREAS Emmanuel Persillier Lachapelle, doctor in medicine, Victor Théodule Daubigny, veterinary sur- geon, director of the French Veterinary School of Montreal,

Orphire Bruneau, veterinary surgeon, director of the Montreal School of Veterinary Surgery, and J. A. Couture, veterinary surgeon, director of the Quebec Veterinary School, all professors of the French Veterinary School of Montreal, affiliated to Laval University, have, by petition, prayed to be incorporated under the name of *L'Ecole de médecine comparée et de science vétérinaire de Montréal* ;

Whereas, for the efficiency of the teaching and for the progress of veterinary science in this Province, it is desirable that all elements and resources be united in one school ;

Whereas, under the circumstances, it is expedient to grant the prayer of the aforesaid petitioners ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. The above-mentioned petitioners, and such persons as they may associate with themselves under the by-laws hereinafter set forth, shall constitute a corporation under the name of "*L'Ecole de médecine comparée et de science vétérinaire de Montréal.*"

Persons incorporated.
Name.

2. The object of the corporation is to teach comparative medicine and veterinary science in the Province, either by the members or by professors appointed to deliver courses of lectures.

Object.

3. The corporation shall have all the rights and powers inherent in ordinary civil corporations.

General powers.

It may acquire, possess and alienate for its use and purposes all kinds of property, moveable and immoveable, provided the annual revenue from immoveables, possessed for revenue purposes, shall not exceed ten thousand dollars.

It may appear before the courts, contract and be contracted with, borrow, sign, endorse or negotiate promissory notes, bills of exchange and other commercial securities for the purposes of the corporation, according to the formalities required to that effect by its by-laws, provided such by-laws have been approved by the Lieutenant-Governor in Council.

4. It may make all by-laws which may be deemed useful or necessary for the management and administration of the property of the corporation, for the admission and exclusion of its members, for the appointment of the president, professors and associates, for making out programmes of instruction, for the distribution, subdivision or increase of chairs of teaching, for the price of admission to the lectures, for the conduct and deportment of the students, for the examinations to be passed to obtain diplomas, and generally for the development and progress of the school, and the teaching of veterinary medicine, and for carrying out the objects of

Power to make by-laws for certain purposes.

the corporation ; provided such by-laws shall not be inconsistent with the provisions of this act.

Certain by-laws to continue in force.

The by-laws of the French Veterinary School of Montreal, which now govern that institution, shall continue to be in force until replaced in the manner hereinafter indicated.

Appointment of members, professors and associates.

5. The members, the president, the professors and the associates of the corporation shall be appointed by the corporation, by the majority of the votes of the members present, in accordance with the by-laws to that effect.

Term of office of president.

The president shall be appointed for three years, and may be re-elected at the expiration of his term.

Removal of members and professors.

6. The members and professors of the school may be removed for cause, by the vote of two-thirds of all the members of the corporation.

Head office.

7. The head office of the corporation shall be in the city of Montreal.

Quorum of meetings.

8. The quorum of the meetings of the corporation shall be three members.

May be changed by by-law.

Another quorum may be fixed by a by-law of the corporation.

Vice-rector may attend meetings so long as school is affiliated to Laval University.

9. So long as the school is affiliated to Laval University, the vice-rector of Laval University at Montreal shall have the right to attend all meetings of the corporation and to give his opinion thereat.

Certificates and diplomas.

10. The corporation is authorized to grant certificates of study or diplomas conferring upon the persons obtaining the same, the right to practise veterinary surgery in the Province.

Who signs the same.

Such diplomas may be signed by the Commissioner of Agriculture, as long as the school receives a subsidy from the Legislature.

Power to affiliate.

11. The corporation is empowered to affiliate to any university and to enter into all agreements for the purpose.

Issue of diplomas, &c., in such case.

In such case, the diplomas may be conferred and the appointments of professors be made by the university, but with the consent of the school.

Certain rights transferred to corporation.

12. The rights and privileges of the French Veterinary School of Montreal and of the Montreal Veterinary School are transferred to *L'Ecole de médecine comparée et de science vétérinaire*.

13. The acts 49-50 Victoria, chapter 37, and 53 Victoria, chapter 80, are repealed. 49-50 V., c. 37, and 53 V., c. 80, repealed.

14. This act shall come into force on the day of its sanction. Coming into force.

An Act to incorporate the Three Rivers District Agricultural Association.

[Assented to 21st December, 1895.]

WHEREAS the Honorable Senators J. J. Ross, of the parish of Ste. Anne de la Pérade and Hippolyte Montplaisir, of Cap de la Madeleine, Pierre Grenier, physician, M.P.P., of St. Maurice, J. B. Massicotte, of St. Prosper, Oréus Beaudoin, of St. Luc, both the two latter farmers, and all of the county of Champlain; T. E. Normand, M.P.P., Alexander Baptist, lumber merchant, P. E. Panneton, banker, Louis Brunelle and Thomas Bournival, merchants, N. L. Denoncourt, advocate, Onésime Carignan, M.P., Téléphore Lymbrenner, machinist, James Malone, trader, L. E. Dufresne and Adelard Gauthier, hotel-keepers, all of the city of Three Rivers; Antoine Desaulniers and Anselme Proulx, farmers, George Héroux, architect, L. A. Lord, notary, of the parish of Yamachiche, F. H. Bellemare, notary, Michel Bourassa, farmer, of St. Barnabé, Pierre Héroux, merchant, of St. Boniface de Shawinigan, and U. Brunelle, notary, of St. Étienne, all of the county of St. Maurice; Hector Caron, M.P.P., of the parish of St. Léon; Edouard Caron, T. H. Legris, M. P., of Rivière du Loup, all of the county of Maskinongé; George Ball, lumber merchant, N. Trahan, merchant, of the town of Nicolet, Achille Leduc, merchant, of Bécancour, T. C. Marchildon, merchant, of St. Pierre les Becquets, all of the county of Nicolet, have, by petition, prayed that an act be passed to incorporate a company for the purpose of establishing and maintaining, on a permanent footing, an agricultural and industrial exhibition for the district of Three Rivers; and whereas it is expedient to grant the prayer of the said petition;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. The persons above-mentioned, and such others as shall hereafter become members of the said association, are incorporated under the name of "The Three Rivers District Agricultural Association," with an authorized capital of twenty-five thousand dollars, divided into two thousand five Persons incorporated.
