

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

College authorized to grant license to J. A. Fortin to practise as physician.

Proviso.

Coming into force.

1. The College of Physicians and Surgeons of the Province of Quebec is authorized to grant unto Joseph Abel Fortin, doctor in medicine of Laval University, residing in the parish of St. Hubert, the necessary license to practise Medicine, Surgery and Obstetrics in this Province, and the said Joseph Abel Fortin shall then be considered as a member of the said college, after he has, however, passed the final examination before the said college.

2. This act shall come into force on the day of its sanction.

### C A P . X C V .

An Act to declare Louis George Lecomte a member of the College of Physicians and Surgeons of the Province of Quebec.

[Assented to 21st December, 1895.]

Preamble.

**W**HEREAS Louis George Lecomte, physician and surgeon, of Jewett city, in Connecticut, one of the United States of America, has, by his petition, represented :

That he has obtained his diploma as physician and surgeon from the Victoria School of Medicine and Surgery, in Montreal, after having duly attended the regular courses of the said school ;

That he commenced to attend the course of lectures of that school before obtaining his diploma of admission to study medicine ;

That he is qualified to practise medicine and surgery ; that he cannot now obtain a license to practise medicine and surgery in the Province of Quebec without the special authorization of the Legislature ;

Whereas he has prayed for the passing of an act declaring him to be, for the future, a member of the College of Physicians and Surgeons of the Province of Quebec, and authorizing the said college to grant him the necessary license for the practice of his profession ;

And whereas the said College does not object to the granting of such authorization ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

L. G. Lecomte declared to be member of College of Physicians.

1. Louis George Lecomte, physician and surgeon, of Jewett city, in Connecticut, one of the United States of America, is declared to be a member of the College of Physicians

and Surgeons of the Province of Quebec, which is authorized to grant him the necessary license for the practice of Medicine, Surgery and Obstetrics in this Province, on his previously passing a final examination before the Board of Examiners of the College of Physicians and Surgeons of the Province of Quebec. Proviso.

**2.** This act shall come into force on the day of its sanction. Coming into force.

## CAP. XCVI.

An Act to authorize Joseph Lacroix to change his name to that of Joseph Archambault.

[Assented to 21st December, 1895.]

**W**HEREAS Joseph Lacroix, commercial agent, of the city and district of Montreal, hath, by his petition, represented : Preamble.

That he was born in the United States of North America of the marriage of Charles Lacroix and Eulalie Cousineau ;

That, from the age of five years, he has resided in the city of Montreal, where he was adopted by Mr. and Mrs. Archambault, who have no children ;

That since his arrival in Montreal he has always been called and known by the name of Joseph Archambault ;

That, under that name, he has always traded, contracted and transacted business, and executed all ordinary deeds, signing the name of Joseph Archambault, and that he is known only under the latter name ;

Whereas the petitioner prays that he be authorized to change his name, and regularly and lawfully bear that of Joseph Archambault ; and whereas it is expedient to grant his prayer ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

**1.** The said Joseph Lacroix is authorized to change his name to that of Joseph Archambault, and may, under the latter name, exercise all his civil rights. Change of name.
