

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

Certain lots in township of Stanfold annexed to Somerset-South.

**1.** Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11 and 12 of the first, second and third ranges ; 1, 2, 3, 4, 5, 6, 7, 8, 9 and 10 of the fourth and fifth ranges ; 1, 2, 3 and 4 of the sixth range, and 1 and 2 of the seventh range, in the township of Stanfold and county of Arthabaska, are detached from the said township and annexed to the township of Somerset South, in the county of Megantic, for all purposes, except for registration purposes.

**2.** Number 2 of the table of electoral districts, in article 64 of the Revised Statutes, describing the county of Arthabaska, is amended by adding, after the word : "Princeville," in the tenth line, the words : "less lots 1 to 12 of the first, second and third ranges, 1 to 10 of the fourth and fifth ranges, 1 to 4 of the sixth range, and 1 and 2 of the seventh range, all inclusive."

## CAP. XII.

An Act to detach the parish of Ste. Flore from the county of Champlain and to annex it to the county of St. Maurice, for all purposes.

[Assented to 12th January, 1895.]

Preamble.

**WHEREAS** the parish of Ste. Flore, in the county of Champlain, is separated from the rest of the county by the River St. Maurice, and it is expedient to annex it to the county of St. Maurice ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

Parish detached from Champlain and annexed to St. Maurice.

**1.** The parish of Ste. Flore, in the county of Champlain, is detached from the said county and annexed to the county of St. Maurice for all purposes.

**2.** The description of the county of Champlain, in number 11 of the table of names and descriptions of the electoral districts of the Province, contained in article 64 of the Revised Statutes, is replaced by the following :

Description of county of Champlain.

"The county of Champlain is bounded, on the South-West, by the River St. Maurice, from its mouth as far as the most northern point where the south-western line of the township of Radnor touches the right bank of the said river ; thence, towards the North-West, by the south-western line of

Radnor, as far as the south-eastern limits of the parish of St. Jacques des Piles ; thence, by the latter limits as far as the south-western limits of the said parish of St. Jacques des Piles ; thence, along the said south-western limits of the parish of St. Jacques des Piles, as far as lakes à la Pêche : thence by the latter lakes and lake à la Truite, as far as the south-western line of the seigniory of Cap de la Madeleine, and thence, by that line prolonged, to the limits of the Province ; on the North-West, by the limits of the Province ; on the South-East, by the River St. Lawrence and the county of Portneuf, following the prolongation of the south-eastern line of the township of Mekinac, as far as the River Batiscan, and thence by the River Batiscan as far as the south-western line of the county of Quebec, and on the North-East, by the counties of Portneuf, Quebec and Lake St. John.

The county, so bounded, comprises the parishes of Ste. Anne, St. François-Xavier de Batiscan, Ste. Geneviève de Batiscan, Champlain and Cap de la Madeleine, that of St. Maurice, which includes the village of Fermont, the parishes of St. Luc, St. Stanislaus, St. Tite, St. Jacques des Piles, St. Prosper, St. Narcisse, Notre-Dame du Mont Carmel, Ste. Thècle, the townships of Radnor, Lejeune, Mekinac, Boucher, Polette, Carignan, Turcotte, Malhiot, Vallière and Langelier, and the unorganized territory within these limits."

3. The description of the county of St. Maurice, contained in number 61 of the said table, as amended by the act 56 Victoria, chapter 44, section 1, is replaced by the following :

"The county of St. Maurice is bounded, on the North-East, by the electoral district of the city of Three Rivers, the River St. Maurice, from the north-western limits of the city of Three Rivers to the most northern point where the south-westerly line of the township of Radnor touches the right bank of the said river ; thence, towards the North-West, by the south-western line of the township of Radnor as far as the south-eastern limits of the parish of St. Jacques des Piles ; thence, by the latter limits, as far as the south-western limits of the parish of St. Jacques des Piles ; thence, by the said south-western limits of the parish of St. Jacques des Piles, as far as lakes à la Pêche, thence, by the latter lakes and lake à la Truite, as far as the south-western line of the seigniory of Cap de la Madeleine, and thence, by the said line prolonged, as far as the limits of the Province ; on the North-West, by the limits of the Province ; on the South-East, by the river St. Lawrence, and on the South-West, by the county of Maskinongé.

The county, so bounded, comprises that part of the parish of Three Rivers, which contains the *lieu* St. Maurice, the parishes of La Pointe du Lac, Yamachiche, St. Sévère, St. Barnabé, St. Etienne, St. Elie, St. Boniface, St. Mathieu and Ste. Flore, the townships of Belleau and Desaulniers, and the unorganized territory within these limits."

4. The mayor of the parish of Ste. Flore shall have and exercise, in the council of the county of St. Maurice, all the powers of a member of such council, except when a question, within the provisions of article 511 of the Municipal Code, arises.

### C A P. X I I I.

An Act respecting the Speaker of the Legislative Council.

**H**ER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. Article 86 of the Revised Statutes is replaced by the following :

"86. The Speaker may be a member of the Executive Council of the Province ;

If he receive a salary as member of the Executive Council, no salary is allowed to him as Speaker of the Legislative Council."

An Act to amend the Quebec License Law.
