

The county, so bounded, comprises that part of the parish of Three Rivers, which contains the *fief* St. Maurice, the parishes of La Pointe du Lac, Yamachiche, St. Sévère, St. Barnabé, St. Etienne, St. Elie, St. Boniface, St. Mathieu and Ste. Flore, the townships of Belleau and Desaulniers, and the unorganized territory within these limits."

4. The mayor of the parish of Ste. Flore shall have and exercise, in the council of the county of St. Maurice, all the powers of a member of such council, except when a question, within the provisions of article 511 of the Municipal Code, arises.

An Act respecting the Speaker of the Legislative Council.

[Assented to 12th January, 1895.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. Article 86 of the Revised Statutes is replaced by the following :

"86. The Speaker may be a member of the Executive Council of the Province ;

If he receive a salary as member of the Executive Council, no salary is allowed to him as Speaker of the Legislative Council."

An Act to amend the Quebec License Law.

[Assented to 12th January, 1895.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. Paragraph 13a of article 828 of the Revised Statutes, as enacted by the act 54 Victoria, chapter 13, section 1,

paragraph 3, and replaced by the act 55-56 Victoria, chapter 11, section 1, is further amended :

1. By inserting, after the word : "grapes," in the second line, the words : "or other fruit ;"

2. By replacing the words : "one gallon," in the fifth line, by the words : "two gallons."

2. Paragraph 13*b* of the said article 828, as enacted by the act 55-56 Victoria, chapter 11, section 1, is amended by adding, after the words : "intoxicating liquors," in the second line, the words : "in quantities not less than two gallons imperial measure, or one dozen bottles of not less than one pint each, imperial measure, at any one time." R. S., 828, § 13*b*, amended.

3. The following paragraph is added after paragraph 31 of the said article 828 : Par. added after R. S., 828, § 31.
 "31*a*. To be a *bond fide* member of a club, within the meaning of this law, a person must have been duly elected and have paid the entrance fee and all other fees fixed by the rules of the club." Member of club defined.

4. The French version of article 834*a* of the said Revised Statutes, as enacted by the act 55-56 Victoria, chapter 11, section 6, is amended by inserting, after the words : "*personne y désignée*," in the fourth line, the words : "*et pour l'établissement y décrit*." French version of R. S., 834*a*, amended.

5. Article 836*b* of the said Revised Statutes, as enacted by the act 57 Victoria, chapter 13, section 4, is amended by adding thereto the following clause : R. S., 836*b*, amended.

"In exceptional cases, the competent authority may, in its discretion, allow the fying of the certificate and application after the said date." Applications after certain date.

6. Paragraph 12 of article 843 of the said Revised Statutes is amended by replacing the words : "by both the police magistrate and recorder," in the last line thereof, by the words : "by the two judges of the sessions and the recorder." R. S., 843, § 12, amended.

7. The following article is added after article 843*a* of the said Revised Statutes : Art. added after R. S., 843*a*.

"843*b*. A certificate for the obtaining of a license, if such certificate has been confirmed before the first of May in any year, shall lapse unless the license is taken out before the thirtieth day of June ; and, if it has been confirmed after the first of May, it shall lapse if the license is not taken out within sixty days after such confirmation." When certificates lapse if license not taken out.

In the city of Montreal, the competent authority may, on the lapsing of a certificate, confirm the certificate of another person, so as to make up the number of licenses fixed by article 843a."

1b. WHOLESALE LIQUOR LICENSE.

856b. Before the granting of a wholesale liquor license, the applicant therefor shall furnish security to the same amount and in the same manner as is required for retail liquor licenses, save that the bond shall be executed in the presence of the proper collector of provincial revenue or in the presence of a justice of the peace residing in the municipality in which the license is applied for."

“**994.** Every collector of provincial revenue, or person ^{Summary ar-} authorized by him, every mayor, secretary, secretary-treas- ^{rest of pedlar.} urer or clerk of any municipality, every constable or officer of the peace, may arrest and detain every pedlar trafficking as aforesaid, and bring him before any justice of the peace of the place where such contravention has been committed, for the purpose of immediately prosecuting him therefor ; but he shall not be detained, without warrant of arrest, ^{Duration of} for any longer space of time than forty-eight hours.” ^{arrest.}

15. Article 995 of the said Revised Statutes is replaced ^{R. S., 995,} by the following : ^{replaced.}

“**995.** Every licensed pedlar, who refuses to exhibit ^{Arrest for} his license to such collector of provincial revenue, ^{refusal to ex-} or person authorized by him, or to such mayor, secretary, ^{hibit license.} secretary-treasurer, clerk, constable or peace officer, upon his request, and after the lapse of a reasonable delay, may, in the same manner, be arrested and brought before any such justice of the peace, and be detained until he has exhibited his license ; provided that, in either case, he be ^{Duration of} not detained, without warrant of arrest, for more than ^{arrest.} forty-eight hours. Such pedlar is liable to a penalty of ^{Penalty.} five dollars for each refusal to exhibit his license.

The judgment inflicting such fine may also order the ^{Confiscation} confiscation of the goods and wares of such pedlar, and ^{of goods.} the sale shall be governed by the provisions of the second clause of article 993.”

16. Article 1062a of the said Revised Statutes, as ^{R. S., 1062a,} enacted by the act 55-56 Victoria, chapter 11, section 34, is ^{amended.} amended by adding after the words : “ collector of provincial revenue,” in the ninth and tenth lines, the words : “ or any person deputed by him.”

An Act to amend the Quebec License Law.

[Assented to 12th January, 1895.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. Article 888 of the Revised Statutes is repealed.
