“ Nevertheless, whenever a club has complied with all the requirements of the law, there shall not be allowed to it a grant of less than twenty-five dollars, in addition to the thirty cents per member deducted for the *Journal of Agriculture*.

C A P. X X V.

An Act to amend the law respecting Public Instruction.

[Assented to 12th January, 1895.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. Article 1973 of the Revised Statutes, as replaced by the act 52 Victoria, chapter 24, section 2, and amended by the acts 53 Victoria, chapter 28, section 1, and 55-56 Victoria, chapter 24, section 10, is replaced by the following :

Alteration of
school muni-
cipalities.

“ 1973. The Lieutenant-Governor in Council may, for school purposes, alter the limits of existing municipalities, divide such municipalities or erect new ones.

Such alterations, subdivisions or erections shall only take place fifteen days after notice to that effect given twice in the *Quebec Official Gazette*, and after the school corporations affected by the proposed changes have been notified, and their observations have been taken into consideration.

Notice of such
changes to be
published, &c.

If such alterations, subdivisions or erections take place, the Lieutenant-Governor in Council may provide that the changes so made shall apply to the religious majority only or to the religious minority only, as the case may require, of the school municipalities affected by such changes, and public notice thereof shall be given in the *Quebec Official Gazette*.

Who gives
notices, &c.,
at whose ex-
pense.

The notices in the Official Gazette and those to the school corporations are given by the superintendent at the expense of the parties applying for such alterations, subdivisions or erections.

Costs of an-
nexation, by
whom to be
paid.

In the case of any annexation of any territory to a school municipality, the costs incurred for such annexation are at the charge of the municipality to which such territory is annexed.”

2. The clause added to article 1988 of the said Revised Statutes by the act 54 Victoria, chapter 21, section 6, is amended by replacing, in the first line thereof, the words : “ During the course of the month of July,” by the words : “ During the thirty days.”

3. Article 2004 of the said Revised Statutes, as amended by R. S., 2004, the acts 55-56 Victoria, chapter 24, section 13, and 57 amended. Victoria, chapter 22, section 9, is further amended by adding thereto the following clause :

“But any person who, under the provisions of this law, may refuse the office of school commissioner or trustee, Resignation of school commissioners, &c. may resign after having accepted it.”

4. The words : “Lieutenant-Governor in Council” are replaced by the words : “Lieutenant-Governor,” wherever R. S., 1913, 1914, 1958, 1964, 1965 and 2035a amended. they occur in the following articles of the said Revised Statutes : 1913, 1914 as amended by the act 55-56 Victoria, chapter 24, section 7, 1958, 1964, 1965 and 2035a as enacted by the act 56 Victoria, chapter 23, section 1.

5. Article 2055 of the said Revised Statutes, as amended R. S., 2055, by the acts 53 Victoria, chapter 27, section 7, and 55-56 amended. Victoria, chapter 24, section 18, is further amended by adding, after the word : “articles,” in the seventh line, the following figures : “1981, 1982, 1983, 1984”.

CAP. XXVI.

An Act to amend the act incorporating the polytechnic school.

[Assented to 12th January, 1895.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. Section 1 of the act 57 Victoria, chapter 23, is 57 V., c. 23, amended : s. 1, amended.

a. By replacing paragraphs 1 and 2 by the following : §§ 1 and 2, replaced.

“1. Of the principal and director of the polytechnic school. Principal and director.

“2. Of two engineers, residing in Montreal, holding diplomas from the polytechnic school, chosen outside of the corps of professors, who shall be elected by the other members of the corporation.” Engineers.

b. By adding, after paragraph 4, the following clause : Par. added after § 4.

“The said corporation may associate unto itself other members, to the number of four, who, being donors, have complied with the conditions and the by-laws to be made respecting benefactors of the institution.” Other members.

2. Section 2 of the said act is amended by replacing the word “professors,” in the first line thereof, by the word Id., s. 2, amended.
