

**3.** Article 2004 of the said Revised Statutes, as amended by R. S., 2004, the acts 55-56 Victoria, chapter 24, section 13, and 57 amended. Victoria, chapter 22, section 9, is further amended by adding thereto the following clause :

“But any person who, under the provisions of this law, may refuse the office of school commissioner or trustee, Resignation of school commissioners, &c. may resign after having accepted it.”

**4.** The words : “Lieutenant-Governor in Council” are replaced by the words : “Lieutenant-Governor,” wherever R. S., 1913, 1914, 1958, 1964, 1965 and 2035a amended. they occur in the following articles of the said Revised Statutes : 1913, 1914 as amended by the act 55-56 Victoria, chapter 24, section 7, 1958, 1964, 1965 and 2035a as enacted by the act 56 Victoria, chapter 23, section 1.

**5.** Article 2055 of the said Revised Statutes, as amended by the acts 53 Victoria, chapter 27, section 7, and 55-56 R. S., 2055, amended. Victoria, chapter 24, section 18, is further amended by adding, after the word : “articles,” in the seventh line, the following figures : “1981, 1982, 1983, 1984”.

## CAP. XXVI.

An Act to amend the act incorporating the polytechnic school.

[Assented to 12th January, 1895.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

**1.** Section 1 of the act 57 Victoria, chapter 23, is 57 V., c. 23, amended : s. 1, amended.

a. By replacing paragraphs 1 and 2 by the following : §§ 1 and 2, replaced.

“1. Of the principal and director of the polytechnic school. Principal and director.

“2. Of two engineers, residing in Montreal, holding diplomas from the polytechnic school, chosen outside of the corps of professors, who shall be elected by the other members of the corporation.” Engineers.

b. By adding, after paragraph 4, the following clause : Par. added after § 4.

“The said corporation may associate unto itself other members, to the number of four, who, being donors, have complied with the conditions and the by-laws to be made respecting benefactors of the institution.” Other members.

**2.** Section 2 of the said act is amended by replacing the word “professors,” in the first line thereof, by the word Id., s. 2, amended.

"director," and the word "three," in the seventh line by the word "two."

amended.

**3.** Section 9 of the said act is amended by adding thereto the following clause :

Approval of  
regulations  
by Lieuten-  
ant-Governor.

"The said regulations must also, to have force and effect, be approved by the Lieutenant-Governor in Council."

**4.** Section 10 of the said act is replaced by the following :

Present staff.

**10.** The present principal, director and professors of the polytechnic school, namely : Urgel Eugène Archambault, principal ; Emile Balète, director of studies and professor ; Charles Albert Pfister, Joseph Haynes, Joseph Emile Vanier, Frédéric André, Saluste Duval, Alexandre Bonnin, professors, shall continue to discharge their duties of principal, director and professors until their appointments shall have been cancelled according to the provisions of the present act, or until their resignations shall have been regularly accepted."

**5.** The first clause of section 11 of the said act is replaced by the following :

How officers  
are appointed.

**11.** The appointment of the principal, director and professors of the school shall be made by the said corporation, by the absolute majority of the votes of its members, according to the by-laws which may be adopted in that respect."

**6.** Section 12 of the said act is amended by striking out all the words after the words "Laval University," in the fifth line.

**7.** Section 13 of the said act is amended by replacing the word "five," in the first line, by the word "four."

**8.** Section 15 of the said act is replaced by the following sections :

**15.** The carrying out of the by-laws, which shall be adopted by the corporation, under this act, shall be entrusted to an executive committee, composed of three members, namely :

1. The principal of the polytechnic school ;
2. The director of studies of the said school ;
3. One of the members of the Catholic Committee of the Council of Public Instruction, named by the said committee.

Report.

The executive committee shall report to the corporation and to the Lieutenant-Governor in Council every year, or oftener if required so to do.

“ 15a. A council of improvement may be established, which shall be composed of the professors of the polytechnic school, and of three pupils, holding diplomas from the said school, selected by the corporation. Council of improvement and its composition, &c.

The council shall give advice as to the modifications that may be advisable to make in the curriculum of studies and on all other matters upon which the management of the polytechnic school deems it expedient to consult it.

The council shall be presided over by the principal or the director of the polytechnic school.”

9. All appointments of directors and professors must be approved by the Lieutenant-Governor in Council. Approval by Lieutenant-Governor of appointments.

10. This act shall come into force on the day of its sanction. Coming into force.

## C A P. XXVII.

An Act to amend the law concerning officers of justice.

[Assented to 12th January, 1895.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. Article 2290 of the Revised Statutes is amended by adding thereto the following clause : R. S., 2290, amended.

“A competent person may also be appointed, in the same manner, clerk of the Superior Court, sitting in review, in the district of Quebec.” Appointment of clerk in review.

2. This act shall come into force on the day of its sanction. Coming into force.

## C A P. XXVIII.

An Act to amend the law respecting the Circuit Court of the District of Montreal.

[Assented to 12th January, 1895.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :
