

“ 157a. A council of improvement may be established, which shall be composed of the professors of the polytechnic school, and of three pupils, holding diplomas from the said school, selected by the corporation. Council of improvement and its composition, &c.

The council shall give advice as to the modifications that may be advisable to make in the curriculum of studies and on all other matters upon which the management of the polytechnic school deems it expedient to consult it.

The council shall be presided over by the principal or the director of the polytechnic school.”

9. All appointments of directors and professors must be approved by the Lieutenant-Governor in Council. Approval by Lieutenant-Governor of appointments.

10. This act shall come into force on the day of its sanction. Coming into force.

C A P. XXVII.

An Act to amend the law concerning officers of justice.

[Assented to 12th January, 1895.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. Article 2290 of the Revised Statutes is amended by adding thereto the following clause : R. S., 2290, amended.

“A competent person may also be appointed, in the same manner, clerk of the Superior Court, sitting in review, in the district of Quebec.” Appointment of clerk in review.

2. This act shall come into force on the day of its sanction. Coming into force.

C A P. XXVIII.

An Act to amend the law respecting the Circuit Court of the District of Montreal.

[Assented to 12th January, 1895.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. The following paragraph is added to section 13 of the act 56 Victoria, chapter 24 : 56 V., c. 24, s. 13, amended.

“ 4. The chief-justice of the Superior Court, or the judge appointed by competent authority to perform the functions Power of chief-justice, &c., over

judges of Circuit Court.

of chief-justice of the Superior Court in the district of Montreal when the chief-justice resides in the city of Quebec, has, respecting the said Circuit Court of the district of Montreal and the judges thereof, the same powers as he has respecting the judges of the Superior Court under the provisions of article 2321 of the Revised Statutes."

Coming into force.

2. This act shall come into force on the day of its sanction.

C A P . X X I X .

An Act respecting the establishment of Commissioners' Courts for the summary trial of small causes.

[Assented to 12th January, 1895.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

R. S., 2408, amended.

1. Article 2408 of the Revised Statutes is amended by inserting the words : "and of at least fifty proprietors of lands or tenements in any", after the word "town," in the second line thereof.

C A P . X X X .

An Act to amend the law respecting justices of the peace.

[Assented to 12th January, 1895.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

Art. added after R., S., 2547.

1. The following article is added after article 2547 of the Revised Statutes :

When oaths to be taken.

"2547*a*. Such oath, together with the oaths of allegiance and of office, shall be taken by such justice of the peace within six months after his appointment, in default whereof his appointment shall be considered as cancelled."

When oaths to be taken by justices of the peace now appointed.

2. Every justice of the peace, who has not taken the required oaths, shall be bound to do so within six months after the coming into force of this act, and, in default thereof, his appointment shall be considered as cancelled.

Coming into force.

3. This act shall come into force on the day of its sanction.
