

## C A P. L X V .

## An Act to amend the act of incorporation of the Philipsburg Junction Railway and Quarry Company.

[Assented to 12th January, 1895.]

## Preamble.

**W**HEREAS the Philipsburg Junction Railway and Quarry Company have, by their petition, represented that they own and operate a line of railway from a point on Missisquoi Bay, in the village of Philipsburg, to the village of Stanbridge station, there connecting with the Central Vermont Railway and with the Canadian Pacific Railway; that it has now become necessary to connect the said line of railway with a point on the Richelieu River, in the county of Missisquoi, and that it is in the interest of the company that the name should be changed; and whereas it is desirable to grant the prayer of the said petition;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

## Name changed.

## Powers continued.

**1.** Henceforth the name of the company shall be "The Philipsburg Railway and Quarry Company;" but, the company, under such new name, shall continue to exercise and enjoy all the rights, powers and privileges granted to the company under its act of incorporation, 51-52 Victoria, chapter 107; and, further, shall be entitled to all the property, rights and privileges acquired by the company since its incorporation, and be subject to all the claims and obligations contracted by the company, or for which the company may be liable since its incorporation.

## Head office and change thereof.

**2.** The principal place of business and the head office of the company shall continue to be in the city of Montreal, unless otherwise determined by a resolution of the directors of the company.

## General powers conferred.

**3.** The company shall also have all the powers conferred by the general law respecting railways in this Province, not inconsistent with this act or the act of incorporation.

## Power to locate, &amp;c., line of railway between certain points.

**4.** The company is vested with all the powers necessary for locating, constructing and working a line of railway, from a point on the line of the railway between Philipsburg and Stanbridge station aforesaid, to a point on the Richelieu River, in the county of Missisquoi.

## Order of building sections.

The company shall have power to build the various sections of such railway in such order as it may deem proper, following the general direction between the aforesaid points.

5. The company shall have power to construct the bridges required for its railway over any river, at such points as it may deem expedient.

Power to build bridges.

6. It is further authorized to construct and work the telegraph and telephone lines required for the working of the railway.

Power to build, &c., telegraph and telephone lines.

## CAP. LXVI.

An Act to amend the act 51-52 Victoria, chapter 101, incorporating the Portage-du-Fort and Bristol Branch Railway Company.

[Assented to 12th January, 1895.]

WHEREAS the Portage-du-Fort and Bristol Branch Railway Company has, by petition, prayed for certain amendments to the act incorporating the same, and it is expedient to grant such prayer;

Preamble.

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. The first clause of section 2 of the act 51-52 Victoria, chapter 101, is replaced by the following :

51-52 V., c. 101, s. 2, amended.

"2. The company shall have power and authority to locate, construct, complete and work a railway, and also a telegraph line throughout the entire length of such railway, from a point at or near Quyon village, or at any practicable point west of Quyon, on the Pontiac Pacific Junction Railway, to the village of Portage-du-Fort."

Power to build certain line of railway, &c.

2. Section 21 of the said act is replaced by the following :

Id., s. 21, replaced.

"21. Work shall be completed within five years from the sanctioning of this act."

## CAP. LXVII.

An Act to define the powers granted by the act 57 Victoria, chapter 71.

[Assented to 12th January, 1895.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. The powers granted by the act 57 Victoria, chapter 71, section 6, are to be construed as limited to the territorial jurisdiction of this Province.

Powers under 57 V., c. 71, s. 6, defined.

2. This act shall come into force on the day of its sanction.
