

CAP. LXXVII.

An Act to continue, in favor of Herbert Molesworth Price, all the rights and privileges granted to Charles Côté, by the act 38 Victoria, chapter 97.

[Assented to 12th January, 1895.]

WHEREAS Herbert Molesworth Price, of Montmorency, Preamble. has, by his petition, represented that he is the assignee of all and singular the rights and privileges granted to Charles Côté, by the act 38 Victoria, chapter 97, and that the said act will expire on the 23rd February next;

Whereas he has prayed that the said powers and privileges so granted to the said Charles Côté, may be continued in his favour for a period of twenty-five years, dating from the said 23rd February now next; and whereas it is expedient, in the interest of persons lumbering on the River Becancour and its tributaries, that the prayer of the said petitioner should be granted;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

I. All and singular the rights and privileges granted to the said Charles Côté, in and by the act 38 Victoria, chapter 97, are hereby continued in favor of Herbert Molesworth Price, of Montmorency, for a period of twenty-five years, to begin on the 23rd day of February now next, and, from and after the said date, the said Herbert Molesworth Price, his heirs and assigns, shall be entitled to exercise all the rights and privileges granted by the said act to the said Charles Côté, in the same manner and to the same effect as though the said act were hereby re-enacted for the further period of twenty-five years, as aforesaid, and as though the name of the said Herbert Molesworth Price were substituted for that of the said Charles Côté, wherever the same appears in the said act, save that the following tariff shall be substituted for that enacted by section 3 of the said act to wit:

2. The said Herbert Molesworth Price shall, from and after the said twenty-third day of February next, during the continuance of the said act, be subject to all and singular the obligations imposed by the said act upon the said Charles Côté.

CAP. LXXVIII.

An Act respecting the Compton Model Farm.

[Assented to 12th January, 1895.]

Preamble.

WHEREAS the Honourable John McIntosh, of the city of Sherbrooke, sheriff, and Herbert D. Smith and Joseph A. Dufort, both of the township of Compton, farmers, have, by petition, represented that they have received and taken possession of certain land and buildings in the county of Compton, granted to them as trustees for the Compton Model Farm, and have prayed that such trustees be incorporated, with a view of teaching the theory and practice of agriculture; and whereas it is expedient to grant their prayer;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

Trustees incorporated.

1. The trustees of the farm situated at Compton, being lots fourteen and fifteen in the sixth range of Compton, containing one hundred and fifty acres, more or less, with buildings, now held in trust by the Honourable John McIntosh, Herbert D. Smith and Joseph A. Dufort, are incorporated, under the name of the "Compton Model Farm," for administering such farm.

Name.

Proviso.

2. The corporation may acquire, accept and receive, by any title, all moveable property, and may sell or otherwise dispose of the same, and exercise all the powers necessary for its purposes.

Composition
of board of
management.

3. The board of management of the said corporation shall consist of three trustees, one to be named by the Government and the two others by the corporation of the village of Compton, two of whom shall form a quorum.

The present trustees, to wit: the Honourable John McIntosh, the Provincial trustee, and Herbert D. Smith and Joseph A. Dufort, the Compton village trustees, shall remain in office until they resign or are replaced: the former by the Government, the two latter by the village of Compton, the council whereof shall make the appointment yearly at their regular meeting in December.

Replacing trustees.

4. The object of the said corporation shall be the theoretical and practical teaching of agriculture.

Object of corporation.

5. The board of management may make regulations for the management and working of the farm, the admission and dismissal of pupils, the theory and practice of farming, the duration and course of study, examinations, granting of diplomas, and concerning all other matters necessary for the efficient working of the farm and the school; and such regulations, before coming into force, shall be approved by the Commissioner of Agriculture.

Regulations to be made by corporation.

6. The board of management shall appoint a superintendent to have the immediate control of the farm.

Superintendent.

7. The Commissioner of Agriculture may, at any time, send a competent person to inspect the said farm and to report thereon.

Inspection.

8. The corporation shall annually submit a report of its operations to the Commissioner of Agriculture.

Report.

9. The acquisition of the said farm and buildings, described in section 1 of this act by the municipality of the village of Compton, is hereby ratified and confirmed.

Certain acquisition of property ratified.

10. The deed of agreement of the nineteenth of March, eighteen hundred and ninety-four, between the Commissioner of Agriculture and the corporation of the village of Compton, is also ratified.

Certain deed of agreement ratified.

11. This act shall come into force on the day of its sanction.
