An Act to incorporate the Master Plumbers' Association of Montreal and its vicinity.

[Assented to 12th January, 1895.]

WHEREAS the persons hereinafter named, with a large number of others in the city of Montreal, have associated themselves under the name of the "Master Plumbers' Association of Montreal, and its vicinity," and have prayed to be incorporated, for the purposes hereinafter mentioned; and whereas it is expedient to grant the prayer of their petition :

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

Carroll, Alphonse Demers, George Yon, George Rosser, Henry Bailey, J. Watson, Francis Brunet, D. Gordon, Wm. Britton, E. C. Mount, J. Sadler, Alfred Blais, F. Horton, and such other persons as are now members or shall hereafter become members of the association, are hereby constituted and shall be a body politic and corporate, by the name of the "Master Plumbers' Association of Montreal," for the following purposes :

Object of corporation.

- (1) For promoting the advancement of the trade in its sanitary, commercial, mechanical and scientific departments;
- (2) For protection against imposition, injustice and encroachment upon its common rights and interests;
- (3) For the education of its members and for the improvement by its members of the plumbing trade generally;
- (4) For the dissemination, among the public, of sanitary science and its principles;
- (5) For the mutual assistance of its members.

2. The principal office of the said corporation shall be in the city of Montreal; but the corporation may establish branches or affiliate with similar associations throughout the Province of Quebec, on such terms and conditions as may be agreed upon or enacted by a resolution of the majority of the members present at a general meeting of the said corporation.

3. The corporation shall have the right to purchase, acquire, hold, possess and enjoy all lands, tenements, hereditaments and all real and immoveable estate, situate in the city of Montreal or its vicinity, necessary for its actual use

and occupation, for the purposes for which it is created; and hypothecate, sell, alienate, exchange and dispose of such property and acquire other instead thereof, whenever the corporation may deem proper so to do; but such real estate shall not exceed the annual value of ten thousand dollars.

Present constitution, &c., of association continued.

4. The constitution, rules and by-laws of the association, now in force, respecting the admission and expulsion of members, the management and conduct generally of its affairs and concerns, in so far as they are not inconsistent with the laws of this Province, shall be the constitution, rules and by-laws of the corporation; provided, always, that the corporation may, from time to time alter, repeal or change, in whole or in part, such constitution, rules and by-laws, in the manner herein provided.

Proviso.

Approval required.

All such by-laws and amendments however, shall, to have force and effect, be previously submitted to the Lieutenant-Governor in Council.

Property vested in corporation and application of revenues.

5. All property owned by or held in trust for the association, is hereby vested in the corporation, and shall be applied solely to the purposes of the corporation; and all debts, claims for subscriptions or contributions of members, or other rights accruing to the association, under its constitution, rules and by-laws, shall be vested in the corporation, and the corporation shall assume the liabilities and obligations of the association.

Members not personally liable for debts of corporation.

6. No member of the corporation shall be liable for any of the debts of the association, beyond a sum equal to the amount of the original entrance fee, and the respective share of every member in the amount of the subsequent contributions or divisions, which might hereafter be levied or allotted between all the members, in equal shares, and which might remain unpaid by such member.

Withdrawal of members after notice, &c.

7. Any member of the corporation, not being in arrears, may retire therefrom, and shall cease to be such member, on giving notice to that effect, in such form as may be required by the constitution, rules and by-laws, and thereafter shall be wholly free from liability for any debt or engagement thereof.

Forfeiture of rights of membership.

8. Every member, expelled or voluntarily retiring from the corporation, or whose name shall be struck off the list of members, for any of the reasons mentioned in the constitution, rules and by-laws, shall forfeit the rights of membership.

9. The rents, revenues and profits, arising out of every description of moveable or immoveable property belonging to the corporation, shall be appropriated for and employed in the exclusive use of the corporation, the construction and repair of the buildings required for the purposes of the corporation, and the payment of expenses legitimately incurred in carrying out any of the objects relating to the aforesaid purposes. Application of revenues, &c.

10. This act shall come into force on the day of its sanction. Coming into force.

An Act to incorporate the *Union St. Joseph de l'Ancienne Lorette.*

[Assented to 12th January, 1895.]

WHEREAS there exists in the parish of L'Ancienne Lorette an association called the *Union St. Joseph de L'Ancienne Lorette*, organized for the purpose of supporting the widows, orphans or heirs of deceased members; Preamble.

Whereas it has become necessary, for the proper working of the association, that it should enjoy the rights, privileges and attributions of an incorporated society;

Whereas the members of the association have, by petition, prayed to be incorporated, and it is expedient to grant their prayer;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

CONSTITUTION AND ORGANIZATION OF THE CORPORATION.

1. Antoine Dion, H. Octave Roy, H. Théophile Pageot, Elzéar Alain, Louis Bédard, Silfrid Dion, and all other persons who now are or may hereafter become members of the association, are constituted a body politic and corporate, under the name of the "*Union St. Joseph de l'Ancienne Lorette.*" Persons incorporated. Name.

2. The principal place of business and the corporate seat of the association is in the parish of L'Ancienne Lorette. Head office.

All regular, general or other meetings, convened in accordance with the by-laws of the association, shall be held in the said parish. Where meetings to be held.

3. All moveable and immoveable property, debts, rights and claims whatsoever, belonging to the association, and Property vested in corporation, &c.
