

9. The rents, revenues and profits, arising out of every description of moveable or immoveable property belonging to the corporation, shall be appropriated for and employed in the exclusive use of the corporation, the construction and repair of the buildings required for the purposes of the corporation, and the payment of expenses legitimately incurred in carrying out any of the objects relating to the aforesaid purposes.

An Act to incorporate the *Union St. Joseph de l'Ancienne Lorette.*

[Assented to 12th January, 1895.]

WHEREAS there exists in the parish of L'Ancienne Lorette an association called the *Union St. Joseph de L'Ancienne Lorette*, organized for the purpose of supporting the widows, orphans or heirs of deceased members;

Preamble.

Whereas it has become necessary, for the proper working of the association, that it should enjoy the rights, privileges and attributions of an incorporated society;

Whereas the members of the association have, by petition, prayed to be incorporated, and it is expedient to grant their prayer;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

CONSTITUTION AND ORGANIZATION OF THE CORPORATION.

1. Antoine Dion, H. Octave Roy, H. Théophile Pageot, Elzéar Alain, Louis Bédard, Silfrid Dion, and all other persons who now are or may hereafter become members of the association, are constituted a body politic and corporate, under the name of the "*Union St. Joseph de l'Ancienne Lorette.*"

Persons incor-

Name.

2. The principal place of business and the corporate seat of the association is in the parish of L'Ancienne Lorette.

Head office.

All regular, general or other meetings, convened in accordance with the by-laws of the association, shall be held in the said parish.

Where meet-

3. All moveable and immoveable property, debts, rights and claims whatsoever, belonging to the association, and

Property vest-
ed in corpora-

the amount of the subscriptions, contributions or other sums due to the latter, are vested in the corporation, which is and shall remain the sole proprietor thereof; but it is also liable for all the debts and obligations of the society, to the exclusion of the members who are not personally liable therefor.

Present by-laws continued, &c.

4. The by-laws and regulations of the association, consistent with the provisions of this act, shall remain in force until amended, repealed or replaced under this act.

Present officers continued in office.

5. The present officers of the association shall remain in office, until replaced in accordance with the by-laws of the corporation.

POWERS AND ATTRIBUTIONS OF THE CORPORATION.

General powers.

6. The corporation shall have perpetual succession and may, within the powers conferred on it by this act :

1. Sue and be sued before all courts of justice ;
2. Contract and bind itself and exercise all the rights, powers and privileges enjoyed by corporations ;
3. Acquire, possess, accept and receive, by purchase, gift, legacy or other title, all moveable and immoveable property ; lease, sell, hypothecate, exchange, or otherwise dispose of the same and substitute others therefor ; provided the value of the said property does not exceed the sum of twenty thousand dollars ;
4. Establish a mutual aid fund in favour of its members.

Power to pass by-laws for certain purposes.

7. The members of the corporation, constituting the quorum determined by by-law, present at a general meeting convened and held in accordance with the by-laws, may amend existing regulations and by-laws, or adopt others respecting :

1. The good government of the corporation and its internal economy ;
2. The administration of its property and affairs ;
3. The admission and expulsion of members ;
4. The determining of the monthly and other contributions to be paid by members ;
5. The amount of aid to be allowed to sick members, their widows, orphans or heirs, and the conditions on which such aid shall be allowed and paid ;
6. The election or appointment of directors and officers, and their duties, powers and obligations ;
7. The sittings and meetings of the directors and members ;
8. Generally, all objects connected with the said corporation, within the limits of this act.

8. The corporation may incur the expenses necessary for its good working and administration. Expenses of working.

MISCELLANEOUS PROVISIONS.

9. The books, registers, by-laws, archives and documents of the association, as well as copies thereof or extracts therefrom, certified to be true by the officer in charge of the same, shall be *prima facie* evidence of their contents in suits between the corporation and its members. Books, &c., to be *prima facie* evidence in certain cases.

10. No member can withdraw from the association until he has paid the corporation all amounts due by and exigible from him. Withdrawal of members.

11. Every member is a competent witness in suits to which the corporation is a party, if there be no other cause of inability or incapacity. Members as witnesses.

12. All sums of money granted by the corporation as aid or assistance are exempt from seizure and attachment, either before or after judgment. Certain mon-
eys not liable
to seizure.

This provision does not extend to amounts due by the corporation to its members under any contract, bargain or undertaking whatsoever. Proviso.

13. The receipt of such aid by the widow, orphans or heirs of a deceased member does not constitute an acceptance of such member's succession. Effect of re-

14. Every amendment to a by-law, every new by-law or repeal of a by-law shall be approved by the members of the corporation, constituting the quorum determined by by-law, present at a general meeting duly convened, and also be approved by the Lieutenant-Governor in Council. Approval of
