#### MISCELLANEOUS PROVISIONS.

9. The books, registers, by-laws, archives and documents of the association, as well as copies thereof or extracts therefrom, certified to be true by the officer in charge of the same, shall be *prima facie* evidence of their contents in suits between the corporation and its members. Books, &c., to be *prima facie* evidence in certain cases.

10. No member can withdraw from the association until he has paid the corporation all amounts due by and exigible from him. Withdrawal of members.

11. Every member is a competent witness in suits to which the corporation is a party, if there be no other cause of inability or incapacity. Members as witnesses.

12. All sums of money granted by the corporation as aid or assistance are exempt from seizure and attachment, either before or after judgment. Certain mon-

This provision does not extend to amounts due by the corporation to its members under any contract, bargain or undertaking whatsoever. Proviso.

13. The receipt of such aid by the widow, orphans or heirs of a deceased member does not constitute an acceptance of such member's succession. Effect of re-

14. Every amendment to a by-law, every new by-law or repeal of a by-law shall be approved by the members of the corporation, constituting the quorum determined by by-law, present at a general meeting duly convened, and also be approved by the Lieutenant-Governor in Council. Approval of

#### C A P. L X X X V I.

An Act to incorporate the *Union St. Joseph de St. Ambroise de la Jeune Lorette*.

[Assented to 12th January, 1895.]

**W**HEREAS there exists in the parish of St. Ambroise de la Jeune Lorette an association called the *Union St. Joseph de St. Ambroise de la Jeune Lorette*, organized for the purpose of supporting the widows, orphans and heirs of deceased members ; Preamble.

Whereas it has become necessary, for the proper working of the association, that it should enjoy the rights, privileges and attributions of an incorporated society ;

Whereas the members of the association have, by petition, prayed to be incorporated, and it is expedient to grant their prayer ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

#### CONSTITUTION AND ORGANIZATION OF THE CORPORATION.

Persons incorporated.

**1.** The Reverend Guillaume Giroux and Jean-Baptiste Bertrand, Cyrille Renaud, Alex. St. Amand, Joseph Renaud, Joseph Boulé, Prosper Martel, Pierre Savard, and all other persons who now are or may hereafter become members of the association, are constituted a body politic and corporate, under the name of the "*Union St. Joseph de St. Ambroise de la Jeune Lorette.*"

Name.

Head office.

**2.** The principal place of business and the corporate seat of the association is in the parish of St. Ambroise de la Jeune Lorette.

Where meetings to be held.

All regular, general or other meetings, convened in accordance with the by-laws of the association, shall be held in the said parish.

Property vested in corporation.

**3.** All moveable and immoveable property, debts, rights and claims whatsoever belonging to the association, and the amount of the subscriptions, contributions or other sums due to the latter, are vested in the corporation, which is and shall remain the sole proprietor thereof ; but it is also liable for all the debts and obligations of the said association, to the exclusion of the members who are not personally liable therefor.

Present rules, &c., continued.

**4.** The rules and regulations of the association, consistent with the provisions of this act, shall remain in force until amended, repealed or replaced under this act.

Present officers continued in office.

**5.** The present officers of the association shall remain in office until replaced in accordance with the by-laws of the corporation.

#### POWERS AND ATTRIBUTIONS OF THE CORPORATION.

General powers.

**6.** The corporation shall have perpetual succession and may :

1. Sue and be sued before all courts of justice in this Province ;

2. Contract and bind itself and exercise, within the limits of its attributions, all the rights, powers and privileges enjoyed by corporations ;

3. Acquire, possess, accept and receive, by purchase, gift, legacy or other title, all moveable and immoveable property ; lease, sell, hypothecate, exchange or otherwise dispose of the same and substitute others therefor, for the purposes of the corporation only ;

4. Establish a mutual aid fund in favour of its members.

7. Two-thirds of the members of the corporation present at a general meeting convened and held in accordance with the by-laws, may amend existing regulations and by-laws, or adopt others respecting :

Power to pass by-laws for certain purposes.

1. The good government of the corporation and its internal economy ;

2. The administration of its property and affairs ;

3. The admission and expulsion of members ;

4. The election of its directors and officers ;

5. The determining of the monthly and other contributions to be paid by members ;

6. The amount of aid to be allowed to sick members, their widows, orphans or heirs, and the conditions on which such aid shall be allowed and paid ;

7. The election or appointment of its directors and officers, and their duties, powers and obligations ;

8. The sittings and meetings of the directors and members ;

9. Generally, all objects within the sphere of the corporation.

The corporation is authorized to incur the expenses necessary for its good working and administration.

Expenses of working.

#### MISCELLANEOUS PROVISIONS.

Members as witnesses.

11. All sums of money granted by the corporation as aid or assistance are exempt from seizure and attachment either before or after judgment.

Certain moneys not liable to seizure.

Proviso.

This provision does not extend to amounts due by the corporation to its members under any contract, bargain or undertaking whatsoever.

Effect of receipt of aid.

**12.** The fact of the widow, orphans or heirs of a deceased member receiving such aid does not constitute an acceptance of such member's succession.

Approval of by-laws, &c.

**13.** Every amendment to any regulation, every new regulation or repeal of a regulation, not permitted or authorized by this act, shall be approved by two-thirds of the members present, at a general meeting duly convened, and also be approved by the Lieutenant-Governor in Council.

Return to Lieutenant-Governor.

**14.** The corporation shall be bound to make an annual return of its operations to the Lieutenant-Governor in Council.

Coming into force.

**15.** This act shall come into force on the day of its sanction.

## C A P . L X X X V I I .

An Act to amend the act 39 Victoria, chapter 70, incorporating The Church Home, of Montreal.

[Assented to 12th January, 1895.]

Preamble.

**W**HEREAS The Church Home, of Montreal, duly incorporated by the act 39 Victoria, chapter 70, has, by its petition, prayed that the said act may be amended so that the said corporation and the management of its affairs shall always be under the direction and governance of the Lord Bishop of the Diocese of Montreal, and it is expedient to grant the prayer of the said petition ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

Direction, &c., under whose control.

**1.** From and after the sanction of this act, the corporation "The Church Home," of Montreal, and the management of its affairs shall always be under the direction and governance of the Lord Bishop of the Diocese of Montreal, who shall always be the president of the said institution.

Approval required for elections, &c.

**2.** The election of directresses, secretary and treasurer, and committee of management, the appointment of the committee of advisers, and the appointment and removal of all subordinate officers and servants of the said corporation, and all other proceedings of the said corporation shall be
