

4. The corporation shall have power to pass such regulations, as may be necessary for the management and conduct of its affairs, either by individuals or by committees, which committees may be composed of persons other than the members of the corporation itself, being always, however, members of the Church of England, and for the appointment and removal of all subordinate officers and servants, and the defining and regulating of their several duties, and the carrying on generally of the work of the institution.

Power to pass by-laws for certain purposes.

The assent of the president shall be necessary to all such regulations, and the appointment and removal of all such subordinate officers and servants, and to all other proceedings of the corporation, and the president shall have power to veto any and all such regulations, appointments, removals and proceedings.

Assent of president required, &c.

Power of veto.

5. The annual meeting of the corporation shall be held on the fourth Wednesday in January of each year, at four o'clock in the afternoon, of which notice shall be given by the secretary, by letter mailed to the address of each member of the corporation, at least five days before the day of meeting.

Annual meeting how convened and when held.

The president may call such other meetings of the corporation at such times and in such manner as he may see fit.

Other meetings.

6. All contracts, agreements, deeds of discharge and other deeds requiring to be executed by the corporation, shall be signed by the president, in the name and on behalf of the corporation, and, when so signed, shall be binding on the corporation.

Signature to deeds, &c.

7. The corporation shall, whenever required by the Lieutenant-Governor in Council, transmit to the three branches of the Legislature a detailed statement of the immoveable property held by it under this act.

Returns to Legislature.

8. This act shall come into force on the day of its sanction.

Coming into force.

CAP. LXXXIX.

An Act to incorporate the Roman Catholic proprietors, tenants and occupants of Dorion Village.

[Assented to 12th January, 1895.]

WHEREAS Frédéric L. Béique, Christophe A. Geoffrion and others, all residing in Dorion Village, have, by petition, represented that, by deed of sale passed before N. Perodeau, notary, on the 8th July, 1892, they purchased the

lot therein described, situate in Dorion Village, and that, by deed of declaration passed on the same day before the same notary, it was stated that such lot had been purchased for the purpose of building a chapel thereon for the exercise of the Roman Catholic religion; that, by deed of obligation passed on the same day, before the same notary, a sum of two thousand dollars was borrowed to aid in paying the cost of a chapel to be built on the same lot; that, shortly after the building of the said chapel, it was blown down by a hurricane; and that, by another deed of obligation, passed before the same notary, on the 12th July, 1893, a new loan was effected, bringing up the total amount of the loan to a sum of four thousand dollars, and that the said chapel has since been rebuilt and has been opened for Roman Catholic worship and re-attended by the people of the place in considerable numbers; that it is necessary to provide for the cost of maintaining the said chapel, for the improvements to be made to it, and for the payment of the said loan; and that, for that purpose, it is urgent that the Roman Catholic proprietors, tenants and occupants of the said Dorion Village be incorporated for the purposes and with the powers hereinafter mentioned;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

Certain persons incorporated.
Name.
Powers.

1. The present and future Roman Catholic proprietors, tenants and occupants of Dorion Village are incorporated under the name of "The Roman Catholic Trustees of Dorion," with power to accept a transfer of the lot of land and chapel above mentioned and to acquire other lots, and hold the same for Roman Catholic worship.

Trustees to manage, how to be elected and after what notice.

2. The said corporation shall act and be represented by a board of trustees, consisting of three persons to be selected every year from amongst the Roman Catholic proprietors of Dorion Village, on the first juridical Saturday of July, at a meeting of the members of the said corporation, convened for that purpose, by a notice given on the previous Sunday, at Divine Service in the chapel, by the officiating priest.

Power to borrow money for certain purposes.

3. In order to provide for the maintenance of the said chapel, the improvement or enlargement thereof, and the rebuilding of the same when necessary, either on the present site or on another site, which may be selected and acquired by the corporation, and for the payment of the said loans and interest thereon, as well as for the payment of the price of all other lots, and for all other expenses in connection with the said chapel, it shall be lawful for the said corporation, acting by the said trustees, to make, renew or

change such loans as may be necessary, by mortgages, debentures or otherwise, with or without a sinking fund; and for the purpose of paying the amount, it may levy, from time to time, such taxes as the said trustees may consider necessary, on the immoveable property of the Roman Catholic proprietors of the said corporation. Before proceeding to the rebuilding of the said chapel, the syndics must however have the approval of the diocesan authority.

May levy taxes to pay loan, &c.

Approval of diocesan authority required.

4. Such taxes shall be levied by a resolution of the said trustees, and be based either upon the real value or upon the annual value of the said immoveables, as established by the valuation roll of the municipality of Dorion Village.

Taxes how levied.

5. The trustees shall make the collection rolls for such taxes, which shall be payable at the expiration of fifteen days from the making of such rolls and their deposit in a place to be indicated by the trustees, and after notice given by the trustees, or by a secretary appointed by them, to the persons obliged to pay the same, with a mention of the amount to be paid by them.

Collection roll and payment of taxes.

6. Such taxes shall be considered as municipal taxes of the said municipality, shall have the same privileges, and shall be collected in the same manner.

Taxes to be considered as municipal taxes, &c.

7. This act shall come into force on the day of its sanction.

Coming into force.

An Act to authorize the *fabrique* of St. François de la Beauce to contract a loan, and for other purposes.

[Assented to 12th January, 1895.]

WHEREAS the *curé* and church-wardens of *l'œuvre et fabrique* of the parish of St. François de la Beauce have, by petition, represented :

Preamble.

That they were authorized by resolutions of the freehold inhabitants of the parish of St. François de la Beauce, at various meetings duly convened and held on the fifth of March, one thousand eight hundred and ninety-three, on the second of April of the same year, and on the second of July, one thousand eight hundred and ninety-four, for and in the name of the said parish, to contract loans, not exceeding in all ten thousand dollars, for the building of a college, a convent, and a hospital in the said parish ;

That the said resolutions have been approved by the diocesan authority ;
