

change such loans as may be necessary, by mortgages, debentures or otherwise, with or without a sinking fund; and for the purpose of paying the amount, it may levy, from time to time, such taxes as the said trustees may consider necessary, on the immoveable property of the Roman Catholic proprietors of the said corporation. Before proceeding to the rebuilding of the said chapel, the syndics must however have the approval of the diocesan authority.

May levy taxes to pay loan, &c.

Approval of diocesan authority required.

4. Such taxes shall be levied by a resolution of the said trustees, and be based either upon the real value or upon the annual value of the said immoveables, as established by the valuation roll of the municipality of Dorion Village.

Taxes how levied.

5. The trustees shall make the collection rolls for such taxes, which shall be payable at the expiration of fifteen days from the making of such rolls and their deposit in a place to be indicated by the trustees, and after notice given by the trustees, or by a secretary appointed by them, to the persons obliged to pay the same, with a mention of the amount to be paid by them.

Collection roll and payment of taxes.

6. Such taxes shall be considered as municipal taxes of the said municipality, shall have the same privileges, and shall be collected in the same manner.

Taxes to be considered as municipal taxes, &c.

7. This act shall come into force on the day of its sanction.

Coming into force.

### C A P. X C.

An Act to authorize the *fabrique* of St. François de la Beauce to contract a loan, and for other purposes.

[Assented to 12th January, 1895.]

WHEREAS the *curé* and church-wardens of the *œuvre et fabrique* of the parish of St. François de la Beauce have, by petition, represented :

Preamble.

That they were authorized by resolutions of the freehold inhabitants of the parish of St. François de la Beauce, at various meetings duly convened and held on the fifth of March, one thousand eight hundred and ninety-three, on the second of April of the same year, and on the second of July, one thousand eight hundred and ninety-four, for and in the name of the said parish, to contract loans, not exceeding in all ten thousand dollars, for the building of a college, a convent, and a hospital in the said parish ;

That the said resolutions have been approved by the diocesan authority ;

That they own a lot, bearing the number fifteen hundred and thirty of the official cadastre of the parish of St. François, for the use of the parish priest of the said parish, and that it is expedient to affect the revenues from the same to the support of the aforesaid college, convent, and hospital ;

Whereas they have, by petition, prayed to be authorized to give effect to the said resolutions and the said intention, and it is expedient to grant their prayer ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

Power to borrow certain sum.

**1.** The *fabrique* of the parish of St. François de la Beauce is authorized to contract loans, not exceeding in all ten thousand dollars, without the previous authorization of the freehold inhabitants of the said parish, for the purpose of building a college, a convent, and an hospital in the said parish.

How loans to be effected.

**2.** The said loans shall be effected in such manner, at such rate of interest, for such period, on such conditions and with such security as the *fabrique* may deem advisable to stipulate.

Application of certain revenues.

**3.** The *fabrique* is also authorized to apply the revenues derived from the immoveable bearing the number 1530 of the official cadastre of the parish of St. François, to the support of the said college, convent and hospital, and, if need be, to give one or more hypothecs thereon, as security for the loans effected or to be effected in virtue of this act.

Coming into force.

**4.** This act shall come into force on the day of its sanction.

## CAP. XCI.

An Act to provide for the civil erection of the parish of St. Louis, at Montreal, and the building of its church.

[Assented to 12th January, 1895.]

Preamble.

**W**HEREAS there has been built in the canonical parish of St. Louis, at Montreal, a church which has been for many years used for Divine worship by Roman Catholics in that parish ;

Whereas such church has been built partly by voluntary contributions, and partly with the revenues of the *fabrique*, and partly by the proceeds of a loan ;

Whereas the said church is not yet completed, and it is urgent that the work necessary to complete the same be done ;
