

stitution, such as the teaching of the catechism, the establishment of novitiates, orphan asylums, day refuges or *crèches*, schools (free or otherwise), boarding schools, work rooms, schools of house-keeping, industrial schools, establishments for the instruction of deaf and dumb girls, retreats and congregations of women and young girls, refuges, hospitals, dispensaries and asylums for infirm or aged women.

9. They shall, as regards persons admitted into their refuges or asylums, have the same powers, rights and privileges as those which are granted to establishments of the same kind in the Province. Rights over persons in refuges, &c.

10. The corporation may exercise such occupations as may be calculated to assist in maintaining it, such as receiving ladies who wish to board in their houses, carrying on industries and disposing of the proceeds thereof; provided they comply with the laws of the Province and the directions of the ecclesiastical authorities. Occupations to be exercised by corporation.

11. The corporation may have or establish a vault or cemetery on the grounds of each of its establishments, for the mortal remains of its members; provided it complies with the laws, prescriptions and regulations in force in connection with this matter. Power to have vault, &c. Proviso.

12. The corporation shall, when required by the Lieutenant-Governor in Council, submit to each of the three branches of the Legislature, a detailed statement of the immoveables which it possesses in virtue of the present act. Return to Legislature.

13. This act shall come into force on the day of its sanction. Coming into force.

CAP. XCIV.

An Act to amend the act incorporating *Les Sœurs des Petites Ecoles de Rimouski*.

[Assented to 12th January, 1895.]

WHEREAS the corporation of *Les Sœurs des Petites Ecoles de Rimouski* has, by petition, prayed that its name be changed to that of *La Corporation des Sœurs de Notre-Dame du St. Rosaire*, and that its powers be extended, and it is expedient to grant such prayer; Preamble.

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

**1.** The name of the corporation of *Les Sœurs des Petites Ecoles de Rimouski*, in the town of St. Germain de Rimouski, in the district of Rimouski, a body politic and corporate, incorporated by the act 43-44 Victoria, chapter 75, is changed to that of *La Corporation des Sœurs de Notre-Dame du St. Rosaire*.

**2.** The corporation, under its new name, shall not be deemed a new corporation, but all deeds, titles, documents and proceedings in which the old name of the community occurs shall be interpreted as if made under the new name.

**3.** Under such new name the corporation, whose corporate seat is in the town of St. Germain de Rimouski, shall have perpetual succession; may have a common seal, which it may alter at will; appear before the courts in the same manner as any person; borrow money, sign bills of exchange and promissory notes; possess, accept and acquire, for the maintenance, use and purposes of the corporation, instituted for the training and education of children in the parish schools of towns and country parts, by any legal title, moveable and immoveable property, which it may sell, alienate, hypothecate, assign, lease, transfer, exchange or otherwise dispose of, by any title whatsoever; provided, always, that the annual revenue of the immoveables possessed by the corporation for the purposes of revenue, shall not exceed thirty thousand dollars.

**4.** The corporation shall be governed according to the rules of the community, and it may, with the approval of its ecclesiastical superiors, adopt or pass rules and regulations, which it may afterwards modify or repeal, respecting the administration of its property, the direction and government of its houses or establishments, the election, number and powers of its officers, the attributions of its members, their admission and withdrawal, and generally adopt or pass all regulations relating to the purposes of the said corporation, not inconsistent with the law.

**5.** The corporation may found branches in any place in this Province, and erect buildings suitable for its purposes, appoint procurators or administrators from amongst its members and define their powers.

**6.** The corporation may, with the consent of the ecclesiastical authorities and in accordance with the rules of its community, carry on all the various works contemplated by its constitution, such as the teaching of the catechism, the establishment of day schools and schools (free or otherwise), in which children shall be prepared for the primary course,

or shall follow an elementary, model or academic course, the direction of work rooms, agricultural schools, schools of house-keeping and industrial schools, and also boarding schools.

7. Every document bearing the signature of the Superiress-General and of her secretary, with the authorization of the general councillors, shall be considered as binding upon the corporation ; but every document from branch establishments civilly incorporated shall further bear the signature of the local superiress.

What documents are binding upon corporation.

8. The corporation may have a cemetery on the property on which the corporate seat is established, for interring the mortal remains of its members, by complying with the ecclesiastical and civil laws, prescriptions and regulations enacted in that respect.

Cemetery for burial of members.

9. The corporation shall, when required by the Lieutenant-Governor in Council, submit to each of the three branches of the Legislature, a detailed statement of the real estate it holds under this act.

Return to Legislature.

10. This act shall come into force on the day of its sanction.

An Act to incorporate the Seventh Day Adventist Conference, of Quebec, and for other purposes.

[Assented to 12th January, 1895.]

WHEREAS the Seventh Day Adventist Conference, which is a Christian body, composed of several Churches of Seventh Day Adventists, represented by the Executive Committee thereof, viz: Elder Joseph Bangs Goode- rich, of South Stukely; Elder Herman Ezra Richard, of Fitch Bay, regularly ordained ministers thereof, and John Harvey Hammond, a local elder of the Church of South Stukely, mill-owner; Darwin Dingman, a local elder of the Church of South Bolton, in the township of Bolton, and Andrew Blake, of South Stukely, all in the Province of Quebec, represents that for the advantage thereof an act to incorporate the said conference is needed, and to authorize the ministers thereof to keep registers of marriages, baptisms and burials, and it is expedient to grant the prayer thereof;
