COPY of the Report of a Committee of the Honourable the Executive Council, dated the 24th February, 1894, approved by the Lieutenant-Governor on the 26th February, 1894.

No. 99.

Respecting certain amendments to the Advocates' Tariff.

The Honourable the Attorney-General, in a report dated the 24th February instant (1894), sets forth :

That at a meeting of the General Council of the Bar, held at Quebec, on the 3rd February, 1894, it was decided to make some changes in the Advocates' Tariff as approved by the Lieutenant-Governor in Council on the 27th June, 1891 ;

That, by a letter dated the 20th February instant, the General Secretary of the Bar forwarded to the Honourable Provincial Secretary a duly certified extract from the minutes of the said meeting, containing the said changes, a copy of which extract is hereunto annexed ;

That it is expedient to approve some of the said changes which lower the fees of advocates.

The Honourable Attorney-General therefore recommends that the changes made by the Bar and mentioned in the said extract from the minutes be approved, with the exception of the item intituled : " special enquête fee," and that the Orders in Council of the 27th June, 1891, Nos. 371 and 372, be amended accordingly.

Extract from the minutes of the meeting of the General Council of the Bar held at Quebec, on the 3rd February, 1894.

It is moved by Mr. Duffy, seconded by Mr. Madore, that the tariff of fees in contested cases in the Superior Court remain as they are, and that, in uncontested cases under \$400, the fees be as they were under the tariff of December 30th, 1868.—Carried.

*Dues on Pulp-wood.*

COPY of a report of a Committee of the Honourable the Executive Council, dated the 16th August, 1894, approved by the Lieutenant-Governor on the 17th August, 1894.

No. 419.

Concerning the dues on Pulp-wood.

The Honourable the Commissioner of Crown Lands, in a report dated the sixteenth of August instant (1894), sets forth that the present rate of dues chargeable on spruce logs for paper pulp is 25c. per cord of 128 cubic feet, and that it is considered advisable to raise it, while allowing a reduction when pulp-wood is to be manufactured in this Province.

Therefore, the Honourable the Commissioner recommends that the rate of dues on spruce logs for paper pulp be fixed at 40c. per cord of 128 cubic feet, but that a reduction of 15c. per cord be allowed when the pulp-wood is to be manufactured in this Province.

Concerning Order in Council No. 419 of the 17th August, 1894.

The Honourable the Commissioner of Crown Lands, in a memorandum dated the fifth of October instant (1894), recommends that Order in Council No 419, passed on the 17th August, 1894, be modified by striking off, in the first paragraph, the words: "while allowing a reduction when pulp-wood is to be manufactured in this Province," and, in the last paragraph, the words: "but that a reduction of 15c. per cord be allowed when the pulp-wood is to be manufactured in this Province."
