

CAP. XVIII.

An Act to amend the law relating to agriculture, respecting farmers' clubs.

[Assented to 8th January, 1894.]

HER MAJESTY, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

R. S., art.
1675c, amend-
ed.

1. Article 1675c of the Revised Statutes, as enacted by the act 56 Victoria, chapter 20, section 10, is amended by adding thereto the following paragraphs :

Amount of
subscriptions
to determine
grant.

"In cases of higher subscriptions, no sum over two dollars per member shall be taken into account in determining the grant made in virtue of article 1675*ii*.

Seed, &c., to
be given
subscribers of
sums over two
dollars.

If more than two dollars are paid by any member, the board of management is authorized to give him seed, fertilizers or any other thing calculated to aid in his farming operations, to an amount equal to the additional sum paid by him."

FARMERS' CLUBS' CO-OPERATIVE SOCIETIES.

1675*rr*. The farmers' clubs of any county or territorial Co-operative

they send to the Commissioner of Agriculture.

If the Commissioner approves their organization into a Name and
co-operative society, he gives notice thereof in the *Quebec* powers.
