

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. The municipal corporation of the town of Nicolet and the municipal corporation of St. Jean Baptiste de Nicolet may each subscribe a sum of eight thousand dollars for rebuilding the Roman Catholic cathedral of Nicolet, and, for that purpose, effect a loan, which shall be repayable at a long term if they so desire, and on such conditions as each of them may deem the best, and, for the repayment of the said sum, impose a tax on the taxable property of Roman Catholics of the parish of St. Jean Baptiste de Nicolet.

Certain subscriptions for rebuilding the cathedral of Nicolet authorized.

An Act to authorize the *curé* and church-wardens of *l'œuvre et fabrique* of the parish of Ste. Scholastique, in the district of Terrebonne, to grant aid towards the rebuilding of the convent of the village of Ste. Scholastique.

[Assented to 8th January, 1894.]

WHEREAS the *curé* and church-wardens of *l'œuvre et fabrique* of the parish of Ste. Scholastique, in the district of Terrebonne, have, by their petition, prayed to be authorized to subscribe and pay, out of the revenues of the said *fabrique*, a sum of four thousand five hundred dollars, in aid of the rebuilding of the convent of the village of Ste. Scholastique ;

Preamble.

Whereas it is established that such is the almost unanimous wish and desire of the freeholders of the said parish of Ste. Scholastique, and whereas the petition is approved by His Grace the Archbishop of Montreal ;

Whereas it is also established that the suppression of the said convent, after an existence of nearly fifty years, would seriously injure the progress and prosperity of the parish of Ste. Scholastique ;

Whereas it is further established that the revenues of the said *fabrique* are sufficient to allow of such subscription, and it is expedient to grant the prayer of the said petition ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. The *curé* and church-wardens of *l'œuvre et fabrique* of the parish of Ste. Scholastique, in the district of Terrebonne, shall have the right, and they are hereby authorized to

subscribe and pay, out of the revenues of the said *fabrique*, a sum of four thousand five hundred dollars, payable either in cash or by instalments of five hundred dollars a year, with interest, to assist the reverend *Sœurs Marianites de Ste. Croix*, or any other religious community, to rebuild the convent of the village Ste. Scholastique.

CAP. LXXXV.

An Act to incorporate the *Ursulines de Stanstead*.

[Assented to 8th January, 1894.]

Preamble.

WHEREAS Mesdames Hélène Létourneau, in religion Sister Marie de L'Immaculée Conception ; Johanna McDonald, in religion Sister Saint Louis de Gonzague ; Alix Roy, in religion Sister Marie des Anges ; Odilus Dion, in religion Sister Sainte Eulalie ; Marguerite Lindsay, in religion Sister Sainte Agathe ; Helen Anderson, in religion Sister Saint Winifred ; M. Angeline Leclerc, in religion Sister Sainte Marie de la Présentation ; M. Alphonsine Drouin, in religion Sister Saint Joseph ; Mary Bushnell *alias* Laboissière, in religion Sister Sainte Marie du Sacré Cœur, all residing at Stanstead Plain, in the village of Stanstead and county of Stanstead, in the Province of Quebec, and teaching young girls there in the monastery which they have established in the said village, have, by their petition, prayed to be incorporated under the name of the "*Ursulines de Stanstead*," with the object of educating and instructing young girls, establishing novitiates, boarding schools, industrial, agricultural and house-keeping schools (free or otherwise), practising works of Christian charity, and acquiring moveable and immoveable property necessary for the development and working of their undertaking ; and whereas it is expedient to incorporate them ;
