An Act to incorporate the *Révérèndes Mères Religieuses Ursulines de Roberval.*

[Assented to 8th January, 1894.]

WHEREAS Mesdames Elise Gosselin, in religion Sister Saint François de Paul ; Fridoline Létourneau, in religion Sister Marie de la Nativité ; Malvina Gagné, in religion Sister Saint Raphaël ; Oliva Paradis, in religion Sister Marie du Sacré-Cœur ; Laure Hudon, in religion Sister Sainte Anne ; Eugénie Cimon, in religion Sister Marie de l'Incarnation ; Alexandrine Gaudrault, in religion Sister Saint Joseph ; Georgina Hudon, in religion Sister Marie de l'Assomption ; Sophie Maltais, in religion Sister Sainte Angèle ; Clorinde Garneau, in religion Sister Sainte Ursule ; Emma Létourneau, in religion Sister Marie de la Providence ; Jennie Hawkins, in religion Sister Marie de l'Immaculée Conception ; Hermina Hudon, in religion Sister Saint Rémi ; Rose Gosselin, in religion Sister Saint Louis ; Phedora Rémillard, in religion Sister Saint Stanislas ; Hélène Belley, in religion Sister Saint François Xavier, all domiciled in the parish of Roberval, in the county of Lake St John, in the Province of Quebec, and teaching young girls there in the monastery which they have established in the town, have, by their petition, prayed to be incorporated under the name of the "*Ursulines de Roberval*," with the object of educating and instructing young girls, establishing novitiates, boarding schools, industrial, agricultural and house-keeping schools (free or otherwise), practising other works of Christian charity, for acquiring and possessing moveable and immoveable property necessary for the development and working of their undertaking ; and whereas it is expedient to incorporate them ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

Certain persons incorporated.

tion ; Hermina Hudon, in religion Sister Saint Rémi ; Rose Gosselin, in religion Sister Saint Louis ; Phedora Rémillard, in religion Sister Saint Stanislas ; Hélène Belley, in religion Sister Saint François Xavier, all residing in the parish of Roberval, county of Lake St. John, and all other persons now forming part of the said community, or who may hereafter form part thereof, in accordance with the rules, statutes and regulations of the said community, are hereby incorporated under the name of the "*Ursulines de Roberval.*"

Name.

General powers.

2. The corporation hereby constituted shall have perpetual succession.

It may have a common seal, which it may alter at will, appear before the courts in the same manner as any person ; borrow money, sign bills of exchange and promissory notes ; possess, accept and acquire, by any legal title, moveable and immovable property, which it may sell, alienate, hypothecate, assign, lease, transfer, exchange or otherwise dispose of, by any title whatsoever ; provided always, that the annual revenue of the immovables possessed by the said community, over and above the board of the pupils, shall not exceed ten thousand dollars, which revenue shall be employed for the purposes of the corporation as herein set forth.

Corporate seat.

3. The corporate seat of the community shall be in the parish of *Notre-Dame du Lac St. Jean*, in the township of Roberval.

Rules to govern and power to pass regulations, &c.

4. The corporation shall be governed according to the rules of the community of the *Ursulines de Québec*, but it may modify the same, and it may adopt or pass rules and regulations (which it may afterwards modify or repeal), respecting the administration of its property, the direction and government of its houses or establishments, the election, number and powers of its directors and officers, the duties of its members, their admission and withdrawal, and generally adopt or pass all regulations relating to the purposes of the said corporation not inconsistent with the law.

Power to found convents, &c.

5. The corporation may found and establish, in all places in this Province, convents, schools and boarding schools, and may erect such buildings as may be suitable for its purposes.

Power to appoint officers, &c.

6. The corporation may appoint officers, procurators or administrators from amongst its members, and define their powers, it may also appoint an attorney outside the community.

7. Every document bearing the signature of the Superior and six councillors, or of any other number of councillors, which may be fixed by the regulations, shall be considered as binding upon the community.

8. The corporation may, with the consent and authorization of the Ordinary of the diocese in which it is situated, do everything connected with its constitution, such as the education and teaching of young girls, the establishment of novitiates, boarding, industrial, agricultural, or house-keeping schools (free or otherwise), and do all other works of Christian charity in conformity with the rules of its order.

9. The immovable properties of the said corporation consist at present of certain immoveables or parcels of land situate in the parish of *Notre-Dame du Lac St. Jean*, in the township of Roberval, on which the *Ursulines de Quebec* have erected the buildings now thereon, to found the monastery of Roberval, acquired in trust for the said corporation by the said Ursuline Ladies, and described as follows, to wit :

"1. A lot of land forming part of lot number eleven of Range B of the original subdivision of the township of Roberval, now known and designated as follows, according to the official plan and book of reference of the cadastre of the village of Roberval, in the county of Lake St John, to wit: numbers one hundred and forty-three (143), one hundred and forty-four (144), one hundred and forty-five (145), one hundred and fifty-five (155), one hundred and fifty-six (156), one hundred and fifty-seven (157), one hundred and fifty-eight (158), one hundred and fifty-nine (159), one hundred and sixty-four (164), one hundred and sixty-five (165), one hundred and sixty-six (166), one hundred and sixty-seven (167), one hundred and sixty-eight (168), one hundred and sixty-nine (169), one hundred and seventy (170), one hundred and seventy-one (171), one hundred and seventy-two (172), one hundred and seventy-three (173), one hundred and seventy-four (174), one hundred and seventy-five (175), one hundred and seventy-seven (177), and two hundred and fifteen (215).

"2. A lot of land forming part of the said number eleven (11), of range B of the original subdivision of the township of Roberval, now known and designated as follows, according to the official plan and book of reference of the cadastre of the township of Roberval, to wit: numbers sixty-one (61) and sixty-two (62).

"3. A lot of land forming part of lot number twelve (12), of range B of the original subdivision of the township of

Roberval, now known and designated under the number sixty (60) of the official plan and book of reference of the cadastre of the township of Roberval,"—which shall revert to the *Ursulines de Québec*, in the event of the said corporation being established elsewhere than at Roberval.

Land to revert if corporation leaves Roberval.

Notice of act and of resolatory clause to be given to registrar.

The better to make public the title of the said corporation to the immoveables transferred to it by this act, and for registration purposes, it shall be sufficient for the corporation to transmit to the registrar of the registration division, in which the said immoveables are situated, a notice of the passing of this act, containing a description of the immoveables, which are declared to belong to it, and the resolatory condition above set forth.

Power to have cemetery, &c.

Proviso.

10. The corporation may have or establish a vault or cemetery on its grounds for the mortal remains of its members ; provided it complies with the laws, prescriptions and regulations respecting the same.

Return to Lieutenant-Governor.

11. The corporation shall, when required by the Lieutenant-Governor, submit a detailed statement of the immoveables which it possesses in virtue of the present act.

Coming into force.

12. This act shall come into force on the day of its sanction.

An Act to amend the act incorporating *La Corporation des Sœurs Marianites de Ste. Croix*.

[Assented to 8th January, 1894.]

Preamble.

WHEREAS *La Corporation des Sœurs Marianites de Ste. Croix* has, by petition, prayed that its name be changed to that of *La Corporation des Sœurs de Ste. Croix et des Sept Douleurs*, and it is expedient to grant their prayer ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

Name changed.

1. The name of *La Corporation des Sœurs Marianites de Ste. Croix*, in the parish of St. Laurent, in the district of Montreal, a body politic and corporate, incorporated by the act 41 Victoria, chapter 32, is changed to that of *La Corporation des Sœurs de Ste. Croix et des Sept Douleurs*.

Powers under new name.

2. The said corporation, under such name, shall not be deemed a new corporation ; and shall, consequently, remain
