

instruction of deaf and dumb girls, retreats and congregations of women or young girls, refuges, hospitals, dispensaries, and asylums for infirm or aged women.

**9.** The corporation and its members shall, as regards persons admitted into their refuges or asylums, have the same powers, rights and privileges granted to the establishments of the same kind in the Province. Powers over persons admitted to refuges, &c.

**10.** The corporation may exercise such occupations as may be calculated to assist in maintaining it, such as receiving ladies, who wish to board in their houses, carrying on industries and disposing of the proceeds thereof; provided they comply with the laws of the Province and the directions of the ecclesiastical authorities. Power given to exercise certain occupations. Proviso.

**11.** The corporation may have or establish a vault or cemetery on the grounds of each of its establishments for the mortal remains of its members; provided it complies with the laws, prescriptions and regulations made by the religious and civil authorities. Power to have cemetery, &c. Proviso.

**12.** The corporation shall, when required by the Lieutenant-Governor in Council, submit to each of the three branches of the Legislature, a detailed statement of the immoveables which it possesses in virtue of the present act. Return to Legislature.

**13.** This act shall come into force on the day of its sanction. Coming into force.

### C A P . L X X X I X .

An Act to incorporate the "Robert Jones Memorial Convalescent Hospital for children of parents belonging to the Church of England in the Diocese of Montreal."

[Assented to 8th January, 1894.]

**W**HEREAS the persons hereinafter named have, by their petition, prayed that they and their successors be incorporated as hereinafter mentioned, and it is expedient to grant the prayer of such petition; Preamble.

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

**1.** Richard Arthur Archibald Jones; the Right Reverend William Bennett Bond, Lord Bishop of the Diocese of Montreal, of the Church of England in Canada, and his successors, Bishops of the said Diocese; the Very Reverend James Certain persons incorporated.

- Carmichael, Dean of the said Diocese and Rector of St. George's Church, Montreal, and his successors, Rectors of the said Church; Andrew Frederick Gault, Richard White, George F. C. Smith, George E. Drummond, Dr. Alexander Johnson, LL.D., Venerable Archdeacon Evans, Reverend John G. Norton, D.D., Reverend Canon Mills, B.D., Reverend J. Frederick Renaud, William M. Ryder, and such other persons as may hereafter be associated with them in conformity with this act, and their successors, are hereby constituted and created a body corporate, with all the rights incident to corporations, by the name of the "Robert Jones Memorial Convalescent Hospital for children of parents belonging to the Church of England in the Diocese of Montreal," and by such name shall have power at all times to purchase, take, have, hold, receive, enjoy, possess and retain all lands, tenements and immoveable property, and all moneys, goods, debts, credits, and other description of moveable and personal property, by any and every description of title—whether gift, purchase, devise, will, lease or otherwise, and such property to hypothecate as security for loans or otherwise, and the same also to let, lease, exchange, sell or otherwise alienate or dispose of, without prejudice to such trusts and conditions as may be declared of and concerning the same in the title under which they may be held; provided always, that the annual value of such immoveable property shall not exceed twenty thousand dollars.
- 2.** The said corporation shall have power to administer their property and affairs, and to make all contracts which by law such corporations may enter into, and to make all by-laws, not contrary to law or the provisions of this present act, for the government of the corporation and the administration of its affairs generally, the admission and expulsion of inmates, and the admission as members of the corporation of other persons than those above named.
- 3.** The said Lord Bishop of Montreal for the time being, and the Rector of St. George's Church at Montreal for the time being, shall be respectively president and vice-president of the said corporation.
- 4.** The said George E. Drummond shall be secretary, and the said William M. Ryder, treasurer of the said corporation, both to continue in office until their successors shall be appointed under the said by-laws.
- 5.** The said corporation may, for all legal purposes, be described as the "Robert Jones Convalescent Hospital."
- 6.** This act shall come into force on the day of its sanction.
