

Whereas he hath prayed that the Bar of the Province of Quebec be authorized to admit him to the practice of the profession of advocate, after the expiration of four years from the date of his having passed the examination admitting him to study;

And whereas the council of the Bar for the section of Montreal have unanimously approved of the petitioner's application, and it is expedient to grant the prayer of the said petitioner;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

1. As soon as the said Louis Gordon Glass shall have completed four years of legal studies, dating from the 5th day of July, 1890, the Bar of the Province of Quebec is hereby authorized to admit the said Louis Gordon Glass as an attorney and advocate, and to allow him to practise law as such, provided he passes the necessary examinations and complies with the prescribed conditions in reference to the same.

CAP. CIII.

An Act to authorize the Bar of the Province of Quebec to admit Camille Piché amongst its members, after examination.

[Assented to 8th January, 1894.]

Preamble.

WHEREAS Camille Piché, student at law, of the city and district of Montreal, was, on the fifteenth day of December, one thousand eight hundred and ninety, indentured to Messrs. Préfontaine, St. Jean and Gouin, advocates, of Montreal:

Whereas he has followed the law lectures of Laval University at Montreal, from that day until the present, and will complete the course of lectures in December next;

Whereas he has been unable, for special reasons, to present himself for examination for the study of the legal profession;

Whereas for over three years he has nevertheless faithfully performed all the obligations of a law student;

Whereas the default of being regularly admitted to the study of law, exposes him to lose the benefit of several years of legal studies;

Whereas the Bar of Montreal has unanimously approved and recommended the passing of a law, authorizing the Bar

of the Province of Quebec to admit the petitioner amongst its members, notwithstanding his not having been admitted to study ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. The Bar of the Province of Quebec is authorized to admit the said Camille Piché to the final examination required for admission to practise law, and to admit him, after such examination, amongst the members of the Bar of this Province.

C. Piché may be received as an advocate, after examination.

2. This act shall come into force on the day of its sanction.

An Act to declare Joseph Herménégilde Chalifoux a member of the College of Physicians and Surgeons of the Province of Quebec.

[Assented to 8th January, 1894.]

WHEREAS Joseph Herménégilde Chalifoux, physician and surgeon, of the city of St. Hyacinthe, has, by his petition, represented :

Preamble.

That he has obtained a diploma of physician and surgeon from the Victoria School of Medicine and Surgery at Montreal, after having duly followed the regular course of lectures of the said school ;

That he commenced to follow the lectures of the said school before having obtained his certificate admitting him to the study of medicine ;

That he is qualified to practise medicine and surgery ;

That he cannot now receive his license to practise medicine and surgery in the Province of Quebec, without special authority from the Legislature ;

Whereas he has prayed for the passing of an act declaring that he shall hereafter form part of the College of Physicians and Surgeons of the Province of Quebec, and to authorize the said college to grant him the license required for the practice of his profession ;

And whereas the College of Physicians and Surgeons of this Province does not oppose the granting of such authorization, but consents thereto ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :
