

of the Province of Quebec to admit the petitioner amongst its members, notwithstanding his not having been admitted to study ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. The Bar of the Province of Quebec is authorized to admit the said Camille Piché to the final examination required for admission to practise law, and to admit him, after such examination, amongst the members of the Bar of this Province.

C. Piché may be received as an advocate, after examination.

2. This act shall come into force on the day of its sanction.

An Act to declare Joseph Herménégilde Chalifoux a member of the College of Physicians and Surgeons of the Province of Quebec.

[Assented to 8th January, 1894.]

WHEREAS Joseph Herménégilde Chalifoux, physician and surgeon, of the city of St. Hyacinthe, has, by his petition, represented :

Preamble.

That he has obtained a diploma of physician and surgeon from the Victoria School of Medicine and Surgery at Montreal, after having duly followed the regular course of lectures of the said school ;

That he commenced to follow the lectures of the said school before having obtained his certificate admitting him to the study of medicine ;

That he is qualified to practise medicine and surgery ;

That he cannot now receive his license to practise medicine and surgery in the Province of Quebec, without special authority from the Legislature ;

Whereas he has prayed for the passing of an act declaring that he shall hereafter form part of the College of Physicians and Surgeons of the Province of Quebec, and to authorize the said college to grant him the license required for the practice of his profession ;

And whereas the College of Physicians and Surgeons of this Province does not oppose the granting of such authorization, but consents thereto ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

1. From and after the sanctioning of this act, Joseph Herménégilde Chalifoux, physician and surgeon, of the

city of St. Hyacinthe, is declared to be a member of the College of Physicians and Surgeons of the Province of Quebec, which is authorized to grant him the license required for the practise of Medicine, Surgery and Midwifery in this Province ; provided that he passes an examination upon the practice of medicine before the Provincial Medical Board.

C A P. C V.

An Act to authorize the College of Physicians and Surgeons of this Province to admit, amongst its members, Thomas Thaddæus Nesbitt, Doctor of Medicine of Laval University.

[Assented to 8th January, 1894.]

Preamble.

WHEREAS Thomas Thaddæus Nesbitt, of the city of Quebec, Doctor of Medicine, has, by his petition, represented :

That he did not present himself for examination to be admitted to study medicine, but that he had already passed the examination for and been admitted to the study of the law ; that he is an advocate and a bachelor of laws of Laval University ;

That he has been through a complete course of classical studies ;

That he obtained the title and diploma of Doctor of Medicine from Laval University on the 18th September last ;

That this application is approved by the Board of Governors of the College of Physicians and Surgeons of the Province of Quebec, and whereas it is expedient to grant his prayer ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

College authorized to grant license to T. T. Nesbitt, after examination.

1. The College of Physicians and Surgeons for the Province of Quebec is authorized to grant to Thomas Thaddæus Nesbitt, Doctor in Medicine of Laval University, residing in the city of Quebec, after examination upon the general practice of medicine, before the Provincial Medical Board, the license required for the practice of medicine, surgery and midwifery in this Province ; and the said Thomas Thaddæus Nesbitt shall then be deemed to form part of the said college.

Coming into force.

2. This act shall come into force on the day of its sanction.
