

6. The following sections are added to the said act after section 13 : Sections added after id., s. 13.

“ **13a.** Articles 4240 and 4241 of the said Revised Statutes are modified, as regards this corporation, in so far that the poll, instead of being held on the Monday following the nomination of the candidates for the office either of mayor or of councillor, shall be held on the seventh juridical day following the date of the nomination. When poll to be held. ”

“ **13b.** Article 4243 of the said Revised Statutes is modified, as regards this corporation, so that the poll shall be opened at the hour of ten in the forenoon and shall be closed at the hour of seven in the afternoon of the same date. Hour for opening and closing poll. ”

7. Section 14 of the said act is replaced by the following : Id., s. 14, replaced.

“ **14.** The council of the said corporation shall have power to issue notes, signed by the mayor and countersigned by the secretary-treasurer, to pay the debts, accounts and other claims connected with the administration of the affairs of the corporation, but only to an amount not exceeding the annual receipts of the corporation. Power to issue notes for certain purposes. ”

8. Section 15 of the said act is amended by adding the following paragraph thereto : Id., s. 15, amended.

“ The said council shall further have power to grant a discount, of not more than five per cent, to rate-payers who shall pay their general or special taxes within the delay which the council shall determine each year. Discount on taxes, paid before certain time. ”

An Act to erect a new village municipality in the western part of Côteau St. Pierre, in the parish of Notre-Dame de Grâces.

[Assented to 27th February, 1893.]

WHEREAS the Reverend J. N. Maréchal, *curé* of Notre-Dame de Grâces, and Jérémie Monette, Antoine Monette, Jean-Baptiste Marier, William Trenholme, Antoine Gauthier, Israël Gauthier, Alfred Arcand, Alfred Doré, Timothé Loisselle, Alphonse Gougeon and many other residents of the western part of Côteau St. Pierre, in Preamble.

the parish of Notre-Dame de Grâces, in the county of Hochelaga, have prayed for the passing of an act for the erection of a new village municipality in the said parish, comprising a certain part of Côteau St. Pierre, as hereinafter described, and that it is expedient to grant the said petition ;

Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows :

Village erected.

1. A new village municipality is erected in the parish of Notre-Dame de Grâces and shall comprise, chiefly, certain lands situated in the western part of Côteau St. Pierre, to wit : all the lands from the farms of Charles Decarie and that of E. G. Evans, both included, as far as the limits of the parish of Lachine, the said municipality being bounded on the north-east by the north-east lines of the farms of Charles Decarie and E. G. Evans ; to the south by the Lachine Canal ; to the north-west by the farms of Côte St. Luc, and to the west by the limits of the parish of Lachine.

Boundaries.

Name.

Laws governing.

2. The said municipality shall be called the " Municipality of the Village of St. Pierre aux Liens ", and shall be governed by the provisions of the Municipal Code of the Province of Quebec, except for the purposes specially provided for in this act.

Division into wards.

3. The municipal council of the village of St. Pierre aux Liens may, at any time, divide the village into three wards.

Number of councillors.

4. When effecting the said division, it shall indicate the number of councillors that each ward may and shall elect.

Who elect councillors.

5. Each councillor can only be elected by the electors of his ward.

Coming into force.

First election, &c.

6. The present act shall only come into force on the first of January, eighteen hundred and ninety-four ; and the election of the first councillors shall take place on the second Monday of the same month, at the hour of ten in the morning. It shall take place in the house of Jérémie Monette, or in any place near thereto, and shall be presided over by the mayor of Notre-Dame de Grâces-Ouest.
