

CAP. LVII.

An Act to incorporate Dorion Village.

[Assented to 30th December, 1890.]

Preamble.

WHEREAS the majority of the rate-payers and residents of the municipality of the parish of St Michel de Vaudreuil, in the district of Montreal, have prayed to be incorporated as a distinct and separate village, under the name of "Dorion Village";

Whereas the said petitioners fulfill the required conditions to be incorporated as a village municipality;

Whereas it is in the interest of the petitioners that they be constituted a corporation separate and distinct from the parishes of St. Michel de Vaudreuil and of Ste Jeanne de Chantal de l'île Perrot;

Whereas it is expedient to grant such prayer; Therefore, Her Majesty, by and with the advice and consent of the Legislature of Quebec, enacts as follows:

TITLE I.

CONSTITUTION OF THE CORPORATION.

Certain territory

1. The following territory, to wit:

"The territory bounded on the north by number four hundred and sixty-two (462) of the official cadastre of the parish of St. Michel de Vaudreuil; on the south by numbers one hundred and thirty-eight and one hundred and thirty-nine (138-139) of such cadastre; on the east by a line passing in the Ottawa river and containing from the numbers three hundred and forty-seven (347) inclusively to three hundred and eighty-four (384) also inclusively, of the official cadastre of the parish of Ste. Jeanne de Chantal de l'île Perrot; and on the west by a line passing five hundred English feet from the Quinchien road, on numbers one hundred and forty (140), one hundred and forty-one (141), one hundred and forty-two (142), one hundred and forty-three (143), one hundred and forty-four (144), three hundred and sixty-six (366), two hundred and thirty-eight (238), three hundred and sixty-seven (367), two hundred and sixty eight (268), three hundred and sixty-eight (368), four hundred and fifty-eight (458), four hundred and fifty-nine (459), four hundred and sixty (460), and four hundred and sixty-one (461) of the official cadastre of the parish of St. Michel de Vaudreuil", is constituted a separate and distinct municipality, under the name of the "Municipality of Dorion Village"; but the properties comprised in the limits of five hundred feet situate alongside of the Quinchien road, shall

be taxable only when they shall have been divided into village lots.

2. The inhabitants and rate-payers of this municipality are constituted a village corporation under the name of "The Corporation of Dorion Village," for municipal purposes only. Inhabitants constituted a corporation. Name.

3. This act shall in nowise affect the present territorial division for parochial, school and registration purposes. Application of act limited.

4. The said municipality and corporation shall be subject to the law governing town corporations (articles 4178 and following of the Revised Statutes of the Province of Quebec), except in so far as this act derogates therefrom or contains provisions inconsistent therewith. R. S. Q. art. 4178 and following, to apply.

TITLE II.

THE COUNCIL.—MUNICIPAL ELECTIONS.

5. The corporation shall be represented by a mayor and six councillors, elected, the former, for one year, and the latter for three years. Mayor and councillors.

Two of the councillors elected at the first election shall remain only one year in office ; two others shall go out of office the following year.

Those who shall so go out of office before the expiration of their term shall be designated by a system of drawing lots in the manner determined by the council.

6. Notwithstanding article 4214 of the Revised Statutes of Quebec, every person having his domicile or place of business, or who has been a resident householder for two months, under a yearly lease, in the village and possesses all the other qualifications required in such cases by the law governing town corporations, shall be qualified to fill municipal offices in such village. Qualification for municipal office, &c.

7. Article 4216 of the said Revised Statutes is amended, as regards the said corporation, so as to qualify for the office of mayor or councillor any persons who has had his domicile or place of business or has been a resident householder for two months, under a yearly lease in the village during the course of the year preceding the election, and who further possesses the qualifications required by the said law governing town corporations for filling such offices. R. S. Q. art. 4216 amended. Qualification of mayor and councillors.

8. Paragraph 2 of article 4227 of the said Revised Statutes is amended, as regards the corporation of the said village, by adding the following words :

“ Or is a resident householder in the village, under a lease, for two months during the year preceding the election.”

9. The first election of the mayor and councillors shall be held on the thirtieth day or the following juridical day after the coming into force of this act.

The Lieutenant-Governor in Council shall appoint the person who is to preside at such first election.

10. The first election shall be held according to the valuation roll in force, on the first day of May next, in the said parishes of St. Michel de Vaudreuil and Ste. Jeanne de Chantal de l'île Perrot.

11. The persons mentioned in the valuation roll as residents of the new municipality, in accordance with paragraph 14 of article 718 of the Municipal Code, but who shall have been or shall be resident householders in the village, according to the provisions of this act, may vote at the first election.

12. The following elections shall be held on the first juridical day of July.

13. The council shall hold its first session within the limits of the village at the place indicated by the person presiding over the election and subsequent sessions shall be held at the place designated by the council.

The officer presiding over the election shall replace the mayor until he enters into office.

TITLE III.

POWERS OF THE CORPORATION.—TAXATION.

Loans under

14. Loans not exceeding five thousand dollars for one and the same improvement may be effected by a by-law adopted by at least four members of the council.

Special tax for
interest and
sinking fund

Such by-law shall order the imposition of a special tax sufficient to pay the annual interest and to establish a sinking fund of one per cent.

15. The council shall have the powers conferred upon municipal corporations by articles 489, 490, 491, 584, 709, 710, 711, 713 and 714, of the Municipal Code, with respect to taxes and licenses.

16. The islands comprised in the present municipality shall be liable to taxation only for objects from which they derive some benefit, and in such proportion as the council shall established yearly.

TITLE IV

MISCELLANEOUS PROVISIONS.

17. The corporations of the parishes of St. Michel de Vaudreuil and of Ste Jeanne de Chantal de l'île Perrot shall retain their own assets, but they shall be responsible for their own liabilities.

18. The corporations of the said parishes shall levy upon the immoveables situated in the new municipality and on its inhabitants only the taxes on immoveables and capitation taxes due on the first of January next, (1891.)

19. The council of the corporation shall have the right to obtain, free of charge, access to all the books, documents, archives and papers it may require, belonging to the said parishes and their officers.

20. All the acts of the councils of the parishes of St. Michel de Vaudreuil and Ste. Jeanne de Chantal de l'île Perrot shall remain in force until repealed by the new village council.

Certain acts &c., to remain in force until repealed.

21. This act shall come into force on the day fixed by the Lieutenant-Governor in Council.

CAP. LVIII.

An Act to amend the act incorporating the Montreal School of Medicine and Surgery, 8 Victoria, chapter 81, and to ratify certain agreements entered into between the said School and the Roman Catholic Archbishop and Bishops of the ecclesiastical province of Montreal.
